- 2 relating to a pilot program to provide Medicaid coverage of doula
- 3 services.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subchapter B, Chapter 32, Human Resources Code,
- 6 is amended by adding Section 32.02481 to read as follows:
- 7 Sec. 32.02481. MEDICAL ASSISTANCE PILOT PROGRAM FOR DOULA
- 8 SERVICES. (a) In this section:
- 9 (1) "Doula" means a nonmedical birthing coach who
- 10 provides doula services and meets the qualifications for a doula as
- 11 determined by commission rule.
- 12 (2) "Doula services" means nonmedical childbirth
- 13 <u>education</u>, coaching, and support services, including emotional and
- 14 physical support provided during pregnancy, labor, delivery, and
- 15 the postpartum period, or provided intermittently during pregnancy
- 16 and the postpartum period.
- 17 (b) The commission shall establish a pilot program to
- 18 provide medical assistance reimbursement for doula services
- 19 provided by a doula, other than services for which a doula may
- 20 <u>enroll as a provider and receive reimbursement under Section</u>
- 21 32.024(qq). The executive commissioner, in consultation with the
- 22 Perinatal Advisory Council established under Section 241.187,
- 23 Health and Safety Code, by rule shall determine the qualifications
- 24 necessary for an individual to be considered a doula and the doula

- 1 services to be covered under the pilot program.
- 2 (c) Not later than September 1, 2026, the commission shall
- 3 implement the pilot program in:
- 4 (1) the most populous county in this state; and
- 5 (2) the county with the greatest maternal health
- 6 support needs, as determined by the county's maternal and infant
- 7 mortality rates and the number of births in the county by Medicaid
- 8 recipients.
- 9 <u>(d) The commission shall prescribe eligibility requirements</u>
- 10 for participation in the pilot program.
- 11 (e) Not later than September 1 of each year during the
- 12 operation of the pilot program, the commission shall prepare and
- 13 publish on the commission's Internet website a report evaluating:
- 14 (1) the total costs during the preceding year of
- 15 providing medical assistance reimbursement for doula services
- 16 under the pilot program; and
- 17 (2) the impact on birth outcomes for women who receive
- 18 doula services under the pilot program.
- 19 (f) Not later than September 1, 2030, the commission shall
- 20 prepare and submit to the legislature a written report that:
- 21 (1) summarizes the results of the pilot program,
- 22 including the effectiveness of the pilot program in reducing
- 23 maternal mortality rates and racial disparities in health outcomes
- 24 in the geographic areas of this state in which the pilot program
- 25 operates;
- 26 (2) includes feedback from participating doulas and
- 27 recipients who received doula services under the pilot program; and

- 1 (3) includes a recommendation on whether the pilot
- 2 program should be continued, expanded, or terminated.
- 3 (g) The pilot program terminates and this section expires
- 4 September 1, 2031.
- 5 SECTION 2. Notwithstanding Section 32.02481(e), Human
- 6 Resources Code, as added by this Act, the Health and Human Services
- 7 Commission shall prepare and publish the first report required by
- 8 that section not later than September 1, 2027.
- 9 SECTION 3. If before implementing any provision of this Act
- 10 a state agency determines that a waiver or authorization from a
- 11 federal agency is necessary for implementation of that provision,
- 12 the agency affected by the provision shall request the waiver or
- 13 authorization and may delay implementing that provision until the
- 14 waiver or authorization is granted.
- 15 SECTION 4. This Act takes effect September 1, 2025.
