A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to a notification requirement if a public school does not
- 3 have a nurse, school counselor, or librarian assigned to the school
- 4 during all instructional hours.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Subchapter C, Chapter 25, Education Code, is
- 7 amended by adding Section 25.096 to read as follows:
- 8 Sec. 25.096. PARENTAL NOTIFICATION CONCERNING NURSES,
- 9 SCHOOL COUNSELORS, AND LIBRARIANS. (a) In this section:
- 10 <u>(1) "Librarian" means a person certified as a</u>
- 11 librarian under Subchapter B, Chapter 21.
- 12 (2) "Nurse" means a person licensed under Chapter 301,
- 13 Occupations Code.
- 14 (3) "School counselor" means a person certified as a
- 15 school counselor under Subchapter B, Chapter 21.
- (b) Except as otherwise provided by Subsection (i), a public
- 17 school, including an open-enrollment charter school, that does not
- 18 have a full-time nurse, school counselor, or librarian or the
- 19 equivalent of a full-time nurse, school counselor, or librarian
- 20 assigned to be present at the school for more than 30 consecutive
- 21 instructional days during the same school year shall provide
- 22 written notice of the absence to the parent of or other person
- 23 standing in parental relation to each student enrolled in the
- 24 school.

- 1 (c) A school has the equivalent of a full-time nurse under
- 2 Subsection (b) if the school has two or more nurses assigned to the
- 3 school and all regular student instructional hours at the campus
- 4 during the regular school day are covered by the assignment of at
- 5 least one nurse.
- 6 (d) A school has the equivalent of a full-time school
- 7 <u>counselor under Subsection (b) if the school has two or more school</u>
- 8 counselors assigned to the school and all regular student
- 9 instructional hours at the campus during the regular school day are
- 10 covered by the assignment of at least one school counselor.
- 11 (e) A school has the equivalent of a full-time librarian
- 12 under Subsection (b) if the school has two or more librarians
- 13 assigned to the school and all regular student instructional hours
- 14 at the campus during the regular school day are covered by the
- 15 <u>assignment of at least one librarian.</u>
- 16 (f) The principal of the school shall provide the notice
- 17 required by Subsection (b) not later than the 30th instructional
- 18 day after the first day the school does not have a full-time nurse,
- 19 school counselor, or librarian assigned to be present at the
- 20 school.
- 21 (g) The school shall:
- 22 (1) make a good faith effort to ensure that the notice
- 23 required by this section is provided in a bilingual form to any
- 24 parent or other person standing in parental relation whose primary
- 25 language is not English; and
- 26 (2) retain a copy of any notice provided under this
- 27 section.

- 1 (h) A school may satisfy the notice requirement under
- 2 Subsection (f) by posting the notice on the school's Internet
- 3 website. Notice posted under this subsection must be accessible
- 4 from the home page of the Internet website by use of not more than
- 5 <u>three links.</u>
- 6 (i) This section does not apply to a school district or
- 7 open-enrollment charter school with a student enrollment of less
- 8 than 10,000 students.
- 9 SECTION 2. This Act applies beginning with the 2025-2026
- 10 school year.
- 11 SECTION 3. This Act takes effect immediately if it receives
- 12 a vote of two-thirds of all the members elected to each house, as
- 13 provided by Section 39, Article III, Texas Constitution. If this
- 14 Act does not receive the vote necessary for immediate effect, this
- 15 Act takes effect September 1, 2025.
