- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subchapter J, Chapter 21, Education Code, is
- 6 amended by adding Section 21.4572 to read as follows:
- 7 Sec. 21.4572. TRAINING FOR SCHOOL ADMINISTRATORS:
- 8 BILINGUAL EDUCATION AND DUAL LANGUAGE IMMERSION. The commissioner,
- 9 <u>in collaboration with relevant stakeholders, shall develop and make</u>
- 10 available training materials and other training resources to
- 11 increase school administrators' understanding of and improve
- 12 student outcomes for:
- (1) bilingual education programs offered under
- 14 Section 29.053; and
- 15 (2) dual language immersion programs described by
- 16 <u>Section 28.0051.</u>
- SECTION 2. Section 29.066(a), Education Code, is amended to
- 18 read as follows:
- 19 (a) A school district that is required to offer bilingual
- 20 education or special language programs shall include the following
- 21 information in the district's Public Education Information
- 22 Management System (PEIMS) report:
- 23 (1) demographic information, as determined by the
- 24 commissioner, on students enrolled in district bilingual education

- 1 or special language programs;
- 2 (2) the number and percentage of students enrolled in
- 3 each instructional model of a bilingual education or special
- 4 language program offered by the district; [and]
- 5 (3) the number and percentage of students identified
- 6 as emergent bilingual students who do not receive specialized
- 7 instruction; and
- 8 (4) any other information required by the agency under
- 9 Section 29.068(b).
- 10 SECTION 3. Subchapter B, Chapter 29, Education Code, is
- 11 amended by adding Section 29.068 to read as follows:
- 12 Sec. 29.068. AGENCY MONITORING. (a) The agency shall adopt
- 13 rules providing for robust monitoring of bilingual education and
- 14 special language programs. The rules must require the agency to:
- 15 (1) review bilingual education and special language
- 16 program requirements to ensure those requirements prioritize
- 17 meeting student needs and closing learning gaps for emergent
- 18 bilingual students; and
- 19 (2) engage directly with school districts offering
- 20 bilingual education or special language programs to improve
- 21 outcomes for emergent bilingual students, including by identifying
- 22 <u>districts offering programs with deficiencies and providing</u>
- 23 <u>technical assistance to those districts.</u>
- 24 (b) Rules adopted under Subsection (a) may include
- 25 requiring school districts that offer bilingual education or
- 26 special language programs to provide additional information
- 27 relevant to the programs through the Public Education Information
