A certified copy of the child's birth certificate submitted under this subsection must be submitted for 15 16 filing under seal and filed separately from any other document. If a certified copy of the child's birth certificate is not available 17 to any party or if the copy does not name both of the child's 18 19 parents, the court may request from any party at any time during the pendency of the suit alternative proof of the identity of the 20 child's parents. The court shall seal or otherwise keep 21 confidential any certificate or other proof submitted under this 22 23 subsection, as applicable.
