- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 5.005, Property Code, is amended to read
- 7 as follows:

- 8 Sec. 5.005. ALIENS. Except as provided by Subchapter H, an
- 9 [An] alien has the same real and personal property rights as a
- 10 United States citizen.
- 11 SECTION 2. Chapter 5, Property Code, is amended by adding
- 12 Subchapter H to read as follows:
- 13 SUBCHAPTER H. PURCHASE OF OR ACQUISITION OF TITLE TO REAL PROPERTY
- 14 BY CERTAIN FOREIGN INDIVIDUALS OR ENTITIES
- Sec. 5.251. DEFINITION. In this subchapter, "control"
- 16 means ownership of, or the power to directly or indirectly vote, 50
- 17 percent or more of the outstanding voting interests of a company or
- 18 other entity, and includes ownership by an individual through one
- 19 <u>or more legal entities.</u>
- 20 Sec. 5.252. EXCEPTION: UNITED STATES CITIZENS AND LAWFUL
- 21 PERMANENT RESIDENTS. This subchapter does not apply to an
- 22 <u>individual who is a citizen or lawful permanent resident of the</u>
- 23 United States, including an individual who is a citizen of a foreign
- 24 country.

1	Sec. 5.253. PROHIBITION ON PURCHASE OF OR ACQUISITION OF						
2	TITLE TO REAL PROPERTY. Except as provided by Section 5.252 and						
3	notwithstanding any other law, the following may not purchase or						
4	otherwise acquire title to real property in this state:						
5	(1) a governmental entity of China, Iran, North Korea,						
6	or Russia;						
7	(2) a company or other entity that is:						
8	(A) headquartered in China, Iran, North Korea, or						
9	Russia;						
10	(B) directly or indirectly under the control of						
11	the government of China, Iran, North Korea, or Russia; or						
12	(C) owned by or under the control of one or more						
13	individuals who are citizens of China, Iran, North Korea, or						
14	Russia;						
15	(3) a company or other entity that is owned by or under						
16	the control of a company or entity described by Subdivision (2); or						
17	(4) an individual who is a citizen of China, Iran,						
18	North Korea, or Russia.						
19	SECTION 3. Subtitle F, Title 10, Government Code, is						
20	amended by adding Chapter 2278 to read as follows:						
21	CHAPTER 2278. PROHIBITION ON CONTRACTS WITH CERTAIN FOREIGN						
22	INDIVIDUALS OR ENTITIES						
23	Sec. 2278.001. DEFINITIONS. In this chapter:						
24	(1) "Adverse foreign entity" means a governmental						
25	entity or a company or other entity described by Section 5.253,						
26	Property Code.						
27	(2) "Governmental entity" has the meaning assigned by

- 2 Sec. 2278.002. PROHIBITED CONTRACTS. (a) This section
- 3 does not apply to an individual who is a citizen or lawful permanent
- 4 resident of the United States, including an individual who is a
- 5 citizen of a foreign country.
- 6 (b) In this section, "public money" means money of this
- 7 state, a state agency, or a political subdivision of this state or
- 8 money the state, state agency, or political subdivision controls or
- 9 directs.
- 10 (c) Except as provided by Subsection (a), a governmental
- 11 entity may not enter into a contract or other agreement payable with
- 12 public money with:
- 13 (1) an adverse foreign entity; or
- 14 (2) an individual who is a citizen of China, Iran,
- 15 North Korea, or Russia.
- SECTION 4. (a) Subchapter H, Chapter 5, Property Code, as
- 17 added by this Act, applies only to the purchase of or other
- 18 acquisition of title to real property on or after the effective date
- 19 of this Act. The purchase of or other acquisition of title to real
- 20 property before the effective date of this Act is governed by the
- 21 law in effect immediately before the effective date of this Act, and
- 22 that law is continued in effect for that purpose.
- 23 (b) Chapter 2278, Government Code, as added by this Act,
- 24 applies only to a contract or other agreement entered into on or
- 25 after the effective date of this Act.
- SECTION 5. This Act takes effect September 1, 2025.
