AMICUS ATTORNEY; MINIMUM QUALIFICATIONS. 15 (a) To be qualified to serve as an amicus attorney, an individual 16 must: 17 (1) be an attorney who: (A) is licensed to practice law in this state and 18 19 in good standing with the State Bar of Texas; 20 (B) has practiced law for at least two years; and 21 (C) is trained in child advocacy or found by the 22 court to have experience equivalent to training in child advocacy; (2) in the four years preceding the appointment, have 23 24 completed not less than a total of four hours of continuing legal education from one or more of the following subject areas: 25 26 (A) domestic violence; 27 (B) techniques for interviewing a child in a

- 1 <u>developmentally appropriate manner; or</u>
- 2 (C) alternative dispute resolution; and
- 3 (3) if appropriate due to the nature of the

- 12 Sec. 107.025. EXCEPTION TO QUALIFICATIONS REQUIRED TO SERVE
- 13 AS AMICUS ATTORNEY IN CERTAIN COUNTIES. (a) This section applies
- 14 only to a county with a population of less than 500,000.
- 15 (b) If a court finds that an individual qualified to serve
- 16 <u>as an amicus attorney under Section 107.0245 is not available in the</u>

9	the person has with another person participating or expected to

11	(6) any other information relating to the person's
12	relationship with an attorney in the suit or the court that a
13	reasonable, prudent person would believe would affect the ability
14	of the person to act impartially as an amicus attorney.
15	(b) The court may not appoint a person as an amicus attorney
16	in a suit if the person makes any of the disclosures in Subsection
17	(a) unless:
18	(1) the court finds, after notice and a hearing, that:
19	(A) the person has no conflict of interest with a
20	party to the suit, the court, or a child who is the subject of the
21	suit;
22	(B) the person's previous knowledge of a party to
23	the suit, the court, or a child who is the subject of the suit is not
24	relevant;
25	(C) the person does not have a pecuniary
26	relationship with an attorney in the suit or the court; and
27	(D) the person does not have a fiduciary

- 1 relationship with an attorney in the suit or the court; or
- 2 (2) the parties agree in writing to the person's
- 3 appointment as an amicus attorney.
- 4 (c) After being appointed as an amicus attorney in a suit, a
- 5 person shall immediately disclose to the court, each attorney for a
- 6 party to the suit, and any party to the suit who does not have an
- 7 attorney any discovery of the following unless previously
- 8 disclosed:
- 9 (1) a conflict of interest that the person believes
- 10 the person has with a party to the suit, the court, or a child who is
- 11 the subject of the suit;
- 12 (2) previous knowledge the person has of a party to the
- 13 suit, the court, or a child who is the subject of the suit, other
- 14 than knowledge obtained in a court-ordered evaluation;
- 15 (3) a relationship that the person has with an
- 16 attorney in the suit who was hired or appointed after the person's
- 17 appointment as an amicus attorney that would have been subject to
- 18 disclosure under Subsection (a); and
- 19 (4) any conflict of interest that the person believes
- 20 the person has with another person who participates in the suit in a
- 21 professional capacity.
- 22 (d) The court shall remove a person as an amicus attorney in
- 23 a suit if the person makes any of the disclosures in Subsection (c)
- 24 unless:
- 25 (1) the court finds, after notice and a hearing, that,
- 26 as applicable:
- 27 (A) the person has no conflict of interest with a

- 1 party to the suit, the court, or a child who is the subject of the
- 2 suit;
- 3 (B) the person's previous knowledge of a party to
- 4 the suit, the court, or a child who is the subject of the suit is not
- 5 relevant;
- 6 (C) the person has no pecuniary or fiduciary
- 7 relationship with an attorney in the suit who was hired or appointed
- 8 after the person's appointment as an amicus attorney; or
- 9 (D) the person has no conflict of interest with
- 10 another person who participates in the suit in a professional
- 11 <u>capacity;</u> or
- 12 (2) the parties agree in writing to the person's

- 19 Sec. 107.026. AMICUS ATTORNEY STANDARD OF CARE. (a) Except
- 20 as provided by this title, an amicus attorney is subject to the
- 21 professional standards of care and ethical standards necessary to
- 22 remain in good standing with the State Bar of Texas.
- 23 <u>(b) A court may impose requirements or adopt local rules</u>
- 24 applicable to an amicus attorney that do not conflict with this

- Sec. 107.0265. POWERS AND DUTIES OF AMICUS ATTORNEY. (a)
- 27 Subject to specific limitations given in an order of appointment

1	under Section 107.024, an amicus attorney's primary duty is to:
2	(1) review the facts and circumstances of the case;

4	(2) advocate the best interests of a child who is the
5	subject of the suit.
6	(b) In performing the duties under Subsection (a), an amicus
7	attorney is not bound by the expressed objectives of a child who is
8	the subject of the suit.
9	(c) An amicus attorney appointed to assist the court:

21	representation by the amicus attorney; and
22	(ii) observe each child while in the care of
23	each party to the suit;
24	(B) interviewing other individuals, including,
25	at the discretion of the amicus attorney, a child who:
26	(i) is not less than four years of age; and
27	(ii) resides part-time or full-time in a

1	residence where a child who is the subject of the suit resides
2	<pre>part-time or full-time;</pre>
3	(C) visiting the residence of each party seeking
4	conservatorship or possession of or access to a child who is the
5	subject of the suit; or
6	(D) reviewing any information the court
7	determines is relevant; and
8	(3) is entitled to:
9	(A) request clarification from the court if the
10	role of the amicus attorney is ambiguous;
11	(B) request a hearing or trial on the merits;
12	(C) consent or refuse to consent to an interview
13	of the child by another attorney;
14	(D) receive a copy of each pleading or other
15	paper filed with the court;
16	(E) receive notice of each hearing in the suit;
17	(F) participate in any case staffing concerning
18	the child conducted by the Department of Family and Protective
19	Services;
20	(G) attend all legal proceedings in the suit; and
21	(H) make arguments during legal proceedings,
22	including:
23	(i) summarizing evidence; and
24	(ii) suggesting reasonable inferences and
25	deductions drawn from the evidence.
26	(d) In preparing for and conducting an interview with a
27	child, an amicus attorney shall:

1	(1) explain the role of an amicus attorney to the child
2	in a developmentally appropriate manner;
3	(2) inform the child in a developmentally appropriate
4	manner that the amicus attorney may use information the child
5	provides in assisting the court; and
6	(3) become familiar with the American Bar
7	Association's standards of practice for attorneys who represent
8	children in custody cases.
9	(e) The disclosure required by Subsections (c)(1)(J) and
10	<u>(K):</u>
11	(1) shall not be construed to require disclosure of an
12	amicus attorney's notes or attorney work product; and
13	(2) is subject to supplementation under Rule 193.5,
14	Texas Rules of Civil Procedure.
15	Sec. 107.027. LIMITATIONS ON AMICUS ATTORNEY POWERS. (a)
16	An amicus attorney may not:
17	(1) offer an opinion regarding conservatorship or
18	possession of or access to a child subject to a suit;
19	(2) engage in ex parte communications with the court;
20	(3) be compelled to produce attorney work product
21	developed during the appointment as an amicus attorney;
22	(4) except as required under Section
23	107.0265(c)(1)(J) or (K), be required to disclose the source of any
24	<pre>information;</pre>
25	(5) submit a report into evidence; or
26	(6) testify in court, except:
27	(A) as authorized under Rule 3.08, Texas

- 1 Disciplinary Rules of Professional Conduct; or
- 2 (B) as necessary for the court to make a
- 3 determination relating to the qualifications, conflicts of
- 4 interest, bias, or removal of the amicus attorney.
- 5 (b) Subsection (a) does not apply to the duty of an attorney
- 6 to report child abuse or neglect under Section 261.101.
- 7 Sec. 107.0275. REMOVAL OF AMICUS ATTORNEY. The court:
- 8 (1) may remove an amicus attorney if the parties agree
- 9 to the removal; and
- 10 (2) shall remove an amicus attorney if, after notice
- 11 and hearing, the court finds that the amicus attorney:
- 12 (A) does not have the minimum qualifications to
- 13 serve as an amicus attorney under Section 107.0245 or 107.025;
- 14 (B) has a conflict of interest or bias under
- 15 <u>Section 107.0255(a) that is not exempted under that section;</u>
- (C) fails to perform duties under Section
- 17 107.0265 or ordered by the court;
- 18 (D) violates a standard of care under Section
- 19 107.026; or
- 20 (E) requests to be removed because a party to the
- 21 suit has prevented the amicus attorney from fulfilling the duties
- 22 <u>of the amicus attorney.</u>
- 23 SECTION 7. Section 107.005, Family Code, is repealed.
- SECTION 8. The changes in law made by this Act apply only to
- 25 a suit affecting the parent-child relationship that is filed on or
- 26 after the effective date of this Act. A suit affecting the
- 27 parent-child relationship filed before the effective date of this

- 1 Act is governed by the law in effect on the date the suit was filed,
- 2 and the former law is continued in effect for that purpose.
- 3 SECTION 9. This Act takes effect September 1, 2025.
