1-19 relating to the composition of the I-27 Advisory Committee.
1-20 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
1-21 SECTION 1. Section 201.623(c), Transportation Code, is
1-22 amended to read as follows:

1-23 (c) The advisory committee is composed of:
1-24 (1) 11 ~~[10]~~ members, one of whom represents each of the
1-25 following counties and is the county judge of the county or an
1-26 elected county official or the administrator of the county road
1-27 department designated by the county judge of the county:

- 1-28 (A) Dallam County;
1-29 (B) Ector County;
1-30 (C) Howard County;
1-31 (D) ~~[(C)]~~ Lubbock County;
1-32 (E) ~~[(D)]~~ Midland County;
1-33 (F) ~~[(E)]~~ Moore County;
1-34 (G) ~~[(F)]~~ Potter County;
1-35 (H) ~~[(G)]~~ Sherman County;
1-36 (I) ~~[(H)]~~ Tom Green County;
1-37 (J) ~~[(I)]~~ Val Verde County; and
1-38 (K) ~~[(J)]~~ Webb County;

1-39 (2) eight ~~[seven]~~ members, one of whom represents each
1-40 of the following municipalities and is the mayor of the
1-41 municipality or the city manager or an assistant city manager
1-42 designated by the mayor of the municipality:

- 1-43 (A) Amarillo;
1-44 (B) Big Spring;
1-45 (C) Del Rio;
1-46 (D) Laredo;
1-47 (E) Lubbock;

1-52 professionals, to be selected based on geographic segments that
