4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Article 2A.008(b), Code of Criminal Procedure,
6	is amended to read as follows:

- 1 person is employed $\underline{\text{or volunteers}}$ at a school district or public
- 2 junior college that has commissioned a peace officer under either

- 4 SECTION 7. This Act takes effect September 1, 2025.
