- 2 relating to the Texas Industry-Recognized Apprenticeship Programs
- 3 Grant Program.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 302.252(1), Labor Code, is amended to
- 6 read as follows:
- 7 (1) "Industry-recognized apprenticeship program"
- 8 means a training program that:
- 9 (A) provides on-the-job training, preparatory
- 10 instruction, supplementary instruction, or related instruction in
- 11 an occupation that has been recognized as an apprenticeable
- 12 occupation by the commission as provided by commission rule [Office
- 13 of Apprenticeship of the United States Department of Labor]; or
- 14 (B) is certified by the commission as an
- 15 industry-recognized apprenticeship program as provided by
- 16 commission rule [by a third-party certifier that has received from
- 17 the United States Department of Labor a favorable determination of
- 18 qualification to award that certification].
- 19 SECTION 2. Section 302.256, Labor Code, is amended by
- 20 adding Subsection (e) to read as follows:
- 21 (e) The commission by rule may distribute payments
- 22 constituting a partial reimbursement to an eligible person as
- 23 milestones for on-the-job training and employment are met by
- 24 program participants, in accordance with the grant terms.

- 1 SECTION 3. Section 302.257, Labor Code, is amended by
- 2 amending Subsection (a) and adding Subsection (a-1) to read as
- 3 follows:
- 4 (a) The commission shall adopt rules to administer and
- 5 enforce this subchapter, including rules establishing:
- 6 (1) which occupations are recognized by the commission
- 7 <u>as an apprenticeable occupation for purposes of this subchapter and</u>
- 8 the criteria for that determination, which must include that the
- 9 occupation:
- 10 (A) be customarily learned in a practical way
- 11 through a structured, systematic program of on-the-job supervised
- 12 training;
- 13 (B) be clearly identified and commonly
- 14 recognized throughout an industry;
- (C) involve manual, mechanical, or technical
- 16 skills or knowledge which requires significant on-the-job work
- 17 experience; and
- 18 (D) require related instruction to supplement
- 19 the on-the-job training;
- 20 (2) a process for and the criteria by which the
- 21 <u>commission may certify a training program as an industry-recognized</u>
- 22 apprenticeship program for purposes of this subchapter;
- 23 (3) performance metrics, including completion rates
- 24 and retention outcomes, for industry-recognized apprenticeship
- 25 program participants trained or employed by a grant recipient using
- 26 grant money awarded under this subchapter;
- 27 (4) timelines for performance metric data reporting by

- 1 grant recipients under this subchapter; and
- 2 (5) a schedule by which the commission annually shall
- 3 make aggregated performance metric data reported by grant
- 4 recipients under this subchapter publicly available on the
- 5 commission's Internet website.
- 6 (a-1) The criteria adopted by the commission under
- 7 Subsection (a)(2) must be generally consistent with the standards
- 8 of apprenticeship prescribed by 29 C.F.R. Section 29.
- 9 SECTION 4. As soon as practicable after the effective date
- 10 of this Act, the Texas Workforce Commission shall adopt the rules
- 11 required by Section 302.257, Labor Code, as amended by this Act.
- 12 SECTION 5. The change in law made by this Act applies only
- 13 to a grant awarded under Subchapter I, Chapter 302, Labor Code, on
- 14 or after the effective date of this Act. A grant awarded before
- 15 that date is governed by the law in effect on the date the grant was
- 16 awarded, and the former law is continued in effect for that purpose.
- 17 SECTION 6. This Act takes effect September 1, 2025.
