AN ACT

2 relating to identifying an individual with veteran's status and

3 providing notice to the Texas Veterans Commission.

- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Sections 13.004(c) and (d), Election Code, are 6 amended to read as follows:
- 7 (c) The following information furnished on a registration
- 8 application is confidential and does not constitute public
- 9 information for purposes of Chapter 552, Government Code:
- 10 (1) a social security number;
- 11 (2) a Texas driver's license number;
- 12 (3) a number of a personal identification card issued
- 13 by the Department of Public Safety;
- 14 (4) the residence address of the applicant, if the
- 15 applicant is a federal judge, including a federal bankruptcy judge,
- 16 a marshal of the United States Marshals Service, a United States
- 17 attorney, or a state judge, a family member of a federal judge,
- 18 including a federal bankruptcy judge, a marshal of the United
- 19 States Marshals Service, a United States attorney, or a state
- 20 judge, the spouse of a peace officer as defined by Article 2A.001,
- 21 Code of Criminal Procedure, or an individual to whom Section
- 22 552.1175, Government Code, or Section 521.1211, Transportation
- 23 Code, applies and the applicant:
- 24 (A) included an affidavit with the registration

- 12 attorney, or a state judge or a family member of a federal judge,
- 13 including a federal bankruptcy judge, a marshal of the United
- 14 States Marshals Service, a United States attorney, or a state
- 15 judge; or
- 16 (C) provided the registrar with a completed form
- 17 approved by the secretary of state for the purpose of notifying the
- 18 registrar of the applicant's status under this subdivision;
- 19 (5) the residence address of the applicant, if the
- 20 applicant, the applicant's child, or another person in the
- 21 applicant's household is a victim of family violence as defined by
- 22 Section 71.004, Family Code, who provided the registrar with:
- (A) a copy of a protective order issued under
- 24 Chapter 85, Family Code, or a magistrate's order for emergency
- 25 protection issued under Article 17.292, Code of Criminal Procedure;
- 26 or
- 27 (B) other independent documentary evidence

- 22 (B) provided the registrar with proof of
- 23 certification under Article 58.059, Code of Criminal Procedure;

- 25 (8) the telephone number of any applicant submitting
- 26 documentation under Subdivision (4), (5), (6), or (7); or
- 27 (9) the applicant's status as a veteran.

- 1 (d) The voter registrar or other county official who has
- 2 access to the information furnished on a registration application
- 3 may not post the following information on a website:
- 4 (1) a telephone number;
- 5 (2) a social security number;
- 6 (3) a driver's license number or a number of a personal
- 7 identification card;
- 8 (4) a date of birth; [or]
- 9 (5) the residence address of a voter who submits
- 10 documentation under Subsection (c)(4), (5), (6), or (7) to the
- 11 voter registrar or regarding whom the registrar has received
- 12 notification under Section 15.0215; or
- 13 (6) an applicant's status as a veteran.
- 14 SECTION 2. Section 13.071, Election Code, is amended by
- 15 adding Subsections (c) and (d) to read as follows:
- 16 <u>(c)</u> The registrar shall compile a list of each submitted
- 17 application for registration that indicates the applicant served in
- 18 the United States armed forces, including their reserve components,
- 19 an auxiliary service of one of the branches of the armed forces, or
- 20 the state military forces as defined by Section 431.001, Government
- 21 <u>Code. The list shall include each applicant's:</u>
- 22 (1) residence address; and
- 23 (2) if provided by the applicant, telephone number.
- 24 (d) The secretary of state shall adopt procedures for the
- 25 transmission of information collected under Subsection (c) to the
- 26 Texas Veterans Commission.
- 27 SECTION 3. Section 13.122, Election Code, is amended by

- 1 amending Subsection (a) and adding Subsection (d) to read as
- 2 follows:
- 3 (a) In addition to the other statements and spaces for
- 4 entering information that appear on an officially prescribed
- 5 registration application form, each official form must include:
- 6 (1) the statement: "I understand that giving false
- 7 information to procure a voter registration is perjury and a crime
- 8 under state and federal law.";
- 9 (2) a space for the applicant's registration number;
- 10 (3) a space for the applicant's Texas driver's license
- 11 number or number of a personal identification card issued by the
- 12 Department of Public Safety;
- 13 (4) a space for the applicant's telephone number;
- 14 (5) a space for the applicant's social security
- 15 number;
- 16 (6) a space for the applicant's sex;
- 17 (7) a statement indicating that the furnishing of the
- 18 applicant's telephone number and sex is optional;
- 19 (8) a space or box for indicating whether the
- 20 applicant or voter is submitting new registration information or a
- 21 change in current registration information;
- 22 (9) a statement instructing a voter who is using the
- 23 form to make a change in current registration information to enter
- 24 the voter's name and the changed information in the appropriate
- 25 spaces on the form;
- 26 (10) a statement that if the applicant declines to
- 27 register to vote, that fact will remain confidential and will be

- 1 used only for voter registration purposes;
- 2 (11) a statement that if the applicant does register
- 3 to vote, information regarding the agency or office to which the
- 4 application is submitted will remain confidential and will be used
- 5 only for voter registration purposes;
- 6 (12) a space or box for indicating whether the
- 7 applicant is interested in working as an election judge;
- 8 (13) a statement warning that a conviction for making
- 9 a false statement may result in imprisonment for up to the maximum
- 10 amount of time provided by law, a fine of up to the maximum amount
- 11 provided by law, or both the imprisonment and the fine; [and]
- 12 (14) a space or box for indicating whether the
- 13 applicant served in the United States armed forces, including their
- 14 reserve components, an auxiliary service of one of the branches of
- 15 the armed forces, or the state military forces as defined by Section
- 16 431.001, Government Code, and a statement acknowledging that:
- 17 (A) providing this information is optional; and
- 18 (B) this information will remain confidential
- 19 and will be used only to print a designation on the voter
- 20 registration certificate and to provide notification of the
- 21 applicant's veteran status to the Texas Veterans Commission, which
- 22 may contact the applicant to connect the applicant with available
- 23 services; and
- 24 (15) [(14)] any other voter registration information
- 25 required by federal law or considered appropriate and required by
- 26 the secretary of state.
- 27 (d) The information furnished by an applicant under

- 1 Subsection (a)(14) may only be used for the purpose described by
- 2 Sections 13.071(c) and (d) or Section 15.001(a).
- 3 SECTION 4. Section 15.001(a), Election Code, is amended to
- 4 read as follows:
- 5 (a) Each voter registration certificate issued must
- 6 contain:
- 7 (1) the voter's name in the form indicated by the
- 8 voter, subject to applicable requirements prescribed by Section
- 9 13.002 and by rule of the secretary of state;
- 10 (2) the voter's residence address or, if the residence
- 11 has no address, the address at which the voter receives mail and a
- 12 concise description of the location of the voter's residence;
- 13 (3) the year of the voter's birth;
- 14 (4) the number of the county election precinct in
- 15 which the voter resides;
- 16 (5) the voter's effective date of registration if an
- 17 initial certificate;
- 18 (6) the voter's registration number;
- 19 (7) an indication of the period for which the
- 20 certificate is issued;
- 21 (8) a statement explaining the circumstances under
- 22 which the voter will receive a new certificate;
- 23 (9) a space for stamping the voter's political party
- 24 affiliation;
- 25 (10) a statement that voting with the certificate by a
- 26 person other than the person in whose name the certificate is issued
- 27 is a felony;

- 1 SECTION 5. Section 18.066(b), Election Code, is amended to
- 2 read as follows:
- 3 (b) Information furnished under this section may not
- 4 include:
- 5 (1) a voter's social security number; [or]
- 6 (2) the residence address of a voter whose residence
- 7 address is confidential under Section 13.004; or
- 8 (3) the voter's status as a veteran, if the voter
- 9 stated on the voter's registration application that the voter
- 10 served in the United States armed forces, including their reserve
- 11 components, an auxiliary service of one of the branches of the armed
- 12 forces, or the state military forces as defined by Section 431.001,
- 13 Government Code.
- 14 SECTION 6. Section 521.011, Transportation Code, is amended
- 15 to read as follows:
- 16 Sec. 521.011. SERVICES INFORMATION FOR VETERANS. (a) In
- 17 this section, "veteran" means:
- 18 (1) a person who receives [The department and the
- 19 Texas Veterans Commission shall jointly develop a one-page
- 20 informational paper about veterans services provided by this state
- 21 for veterans who receive]:
- (A) (A) (A) a driver's license with a designation
- 23 under Section 521.1235; or
- (B) $\left[\frac{(2)}{2}\right]$ a personal identification certificate
- 25 with a designation under Section 521.102; or
- 26 (2) a person who:
- 27 (A) served in the United States armed forces,

- 1 including their reserve components, an auxiliary service of one of
- 2 the branches of the armed forces, or the state military forces as
- 3 defined by Section 437.001, Government Code; and
- 4 (B) did not request or is not eligible for a
- 5 designation described by Subdivision (1).
- 6 (b) The department shall provide to each applicant for an
- 7 original, renewal, corrected, or duplicate driver's license or
- 8 personal identification certificate the opportunity to voluntarily
- 9 indicate for the purposes of this section that the person is a
- 10 <u>veteran. The department shall acknowledge that:</u>
- 11 (1) providing this information is optional; and
- 12 (2) this information will remain confidential and will
- 13 be used only to:
- 14 (A) provide the applicant with a one-page
- 15 informational paper about veterans services provided by this state;
- 16 <u>and</u>
- 17 (B) provide notification of the applicant's
- 18 veteran status to the Texas Veterans Commission, which may contact
- 19 the applicant to connect the applicant with available services.
- 20 (c) The department and the Texas Veterans Commission shall
- 21 jointly develop a process to enable the department to share with the
- 22 Texas Veterans Commission a person's name, veteran status, and
- 23 residence address received under Subsection (b). The Texas
- 24 Veterans Commission may contact the person to connect the person
- 25 with veterans services provided by this state. Information
- 26 received by the department and the Texas Veterans Commission under
- 27 this section is confidential and not subject to disclosure under

- 1 Chapter 552, Government Code.
- 2 <u>(d)</u> The department and the Texas Veterans Commission shall:
- 3 (1) jointly develop a one-page informational paper
- 4 about veterans services provided by this state; and
- 5 (2) provide the informational paper to each person who
- 6 voluntarily indicates to the department under Subsection (b) that
- 7 the person is a veteran.
- 8 SECTION 7. Sections 521.102(c) and 521.1235(c),
- 9 Transportation Code, are repealed.
- 10 SECTION 8. The change in law made by this Act to Section
- 11 13.122(a), Election Code, applies only to a voter registration
- 12 application distributed on or after September 1, 2025. A voter
- 13 registration application distributed before September 1, 2025, is
- 14 covered by the law in effect when the application was distributed,
- 15 and the former law is continued in effect for that purpose.
- SECTION 9. Section 521.011, Transportation Code, as amended
- 17 by this Act, applies only to an application for a driver's license
- 18 or personal identification certificate issued or renewed on or
- 19 after the effective date of this Act. An application for a driver's
- 20 license or personal identification certificate issued or renewed
- 21 before the effective date of this Act is governed by the law in
- 22 effect when the license or certificate was issued or renewed, and
- 23 the former law is continued in effect for that purpose.
- 24 SECTION 10. This Act takes effect September 1, 2025.
