- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 325.008(a), Government Code, is amended
- 6 to read as follows:
- 7 (a) Before January 1 of the year in which a state agency
- 8 subject to this chapter and its advisory committees are abolished,
- 9 the commission shall:
- 10 (1) review and take action necessary to verify the
- 11 reports submitted by the agency under Section 325.007;
- 12 (2) consult the Legislative Budget Board, the
- 13 Governor's Budget, Policy, and Planning Division, the State
- 14 Auditor, and the comptroller of public accounts, or their
- 15 successors, on the application to the agency of the criteria
- 16 provided in Section 325.011;
- 17 (3) conduct a review of the agency based an the
- 18 criteria provided in Section 325.011 and prepare a written report;

- 20 (4) conduct the evaluation required by Section

- 23 recommendations contained in the reports presented to the

- 2 SECTION 2. Chapter 325, Government Code, is amended by
- 3 adding Section 325.0085 to read as follows:
- 4 Sec. 325.0085. RELOCATION OF STATE AGENCY HEADQUARTERS.
- 5 (a) For each state agency reviewed under this chapter whose
- 6 headquarters is located in Travis County or an adjacent county, the
- 7 commission, with the assistance of the Texas Facilities Commission,
- 8 shall evaluate the cost savings to this state of relocating the
- 9 state agency's headquarters to a location outside of Travis County
- 10 or an adjacent county. In determining the cost savings to the
- 11 state, the commission shall consider the following factors over a
- 12 10-year period:
- 13 (1) the cost of leasing or purchasing office space for
- 14 the state agency in a location outside of Travis County or an
- 15 <u>adjacent county;</u>
- 16 (2) the cost of moving the state agency to the new
- 17 location;
- 18 (3) the market value of any state-owned property
- 19 currently being used for the state agency's headquarters, including
- 20 the amount of income the state could earn by leasing or selling the
- 21 property; and
- 22 (4) any other information the commission or Texas
- 23 <u>Facilities Commission considers relevant in determining whether</u>
- 24 the relocation creates a cost saving to this state.
- 25 (b) If the commission determines relocating a state agency
- 26 <u>creates a cost saving to this state, the state agency shall relocate</u>
- 27 the agency's headquarters to the location determined by the
