- and who exercises control and surveillance over all administrative 23

- 1 $\underline{\text{(E)}}$ [$\frac{\text{(5)}}{\text{(5)}}$] there is a single chief medical officer 2 for all of the hospitals who reports directly to the governing body
- 3 and who is responsible for all medical staff activities of the
- 4 hospital;
- 5 (F) $[\frac{(6)}{(6)}]$ each building of a hospital to be
- 6 included in the license that is geographically separate from other
- 7 buildings of the same hospital contains at least one nursing unit
- 8 for inpatients, unless providing only diagnostic or laboratory
- 9 services, or a combination of diagnostic or laboratory services, in
- 10 the building for hospital inpatients; and
- 11 $\underline{\text{(G)}}$ [$\frac{\text{(T)}}{\text{(G)}}$] each hospital that is to be included in

- 15 $\underline{\text{(ii)}}$ [(B)] for a special hospital, if the

- 21 (c-2) The department may recommend a waiver of the

- 2 SECTION 2. As soon as practicable after the effective date
- 3 of this Act, the executive commissioner of the Health and Human
- 4 Services Commission shall adopt rules necessary to implement
- 5 Section 241.023(c-1), Health and Safety Code, as amended by this
- 6 Act.
- 7 SECTION 3. This Act takes effect September 1, 2025.
