

A JOINT RESOLUTION

1 applying to the Congress of the United States to call a convention  
2 under Article V of the United States Constitution for the limited  
3 purpose of proposing one or more amendments to the constitution to  
4 impose fiscal restraints on the federal government, to limit the  
5 power and jurisdiction of the federal government, and to limit the  
6 terms of office of federal officials and members of Congress.

7 WHEREAS, The drafters of the United States Constitution  
8 empowered state legislatures to be guardians of liberty against  
9 abuses of power by the federal government; and

10 WHEREAS, The federal government has abused its power by  
11 creating a crushing national debt through improper and imprudent  
12 spending; and

13 WHEREAS, The federal government has abused its power by  
14 invading the legitimate role of the states through the manipulative  
15 process of federal mandates that are to a great extent unfunded; and

16 WHEREAS, The federal government has ceased to abide by a  
17 proper interpretation of the United States Constitution; and

18 WHEREAS, It is the solemn duty of state legislatures to  
19 protect the liberty of the people and of future generations by  
20 proposing amendments to the United States Constitution that place  
21 clear restraints on federal power; and

22 WHEREAS, Article V of the United States Constitution  
23 authorizes the several state legislatures to restrict the power of  
24 the federal government through the amendment process; and

1 WHEREAS, Article V of the United States Constitution provides  
2 that on application of the legislatures of two-thirds of the  
3 several states Congress shall call a convention for the purpose of  
4 proposing amendments to the constitution; now, therefore, be it

5 RESOLVED, That the 89th Legislature of the State of Texas,  
6 Regular Session, 2025, hereby apply to Congress to call a  
7 convention under Article V of the United States Constitution for  
8 the limited purpose of proposing one or more amendments to the  
9 constitution to impose fiscal restraints on the federal government,  
10 to limit the power and jurisdiction of the federal government, and  
11 to limit the terms of office of federal officials and members of  
12 Congress; and, be it further

13 RESOLVED, That, unless rescinded by a succeeding  
14 legislature, this application by the 89th Legislature of the State  
15 of Texas constitutes a continuing application in accordance with  
16 Article V of the United States Constitution until at least  
17 two-thirds of the legislatures of the several states have applied  
18 to Congress to call a convention for the limited purpose of  
19 proposing one or more amendments to the constitution to impose  
20 fiscal restraints on the federal government, to limit the power and  
21 jurisdiction of the federal government, and to limit the terms of  
22 office of federal officials and members of Congress; and, be it  
23 further

24 RESOLVED, That the Texas secretary of state forward official  
25 copies of this resolution to the president of the United States, to  
26 the speaker of the House of Representatives and the president of the  
27 Senate of the Congress of the United States, and to all members of

1 the Texas delegation to Congress with the request that this  
2 resolution be officially entered in the Congressional Record as an  
3 application to Congress for a convention under Article V of the  
4 United States Constitution for the limited purpose of proposing one  
5 or more amendments to the constitution to impose fiscal restraints  
6 on the federal government, to limit the power and jurisdiction of  
7 the federal government, and to limit the terms of office of federal  
8 officials and members of Congress; and, be it further

9       RESOLVED, That the Texas secretary of state forward official  
10 copies of this resolution to the secretaries of state and to the  
11 presiding officers of the legislatures of the several states with  
12 the request that they join this state in applying to Congress for a  
13 convention under Article V of the United States Constitution for  
14 the limited purpose of proposing one or more amendments to the  
15 constitution to impose fiscal restraints on the federal government,  
16 to limit the power and jurisdiction of the federal government, and  
17 to limit the terms of office of federal officials and members of  
18 Congress.
