12 WHEREAS, Mrs. Glover became a dedicated activist in the 13 grassroots conservative movement; she served her fellow Double Oak 14 residents as precinct chair, and as chair of the Legislative Priorities Committee of the Republican Party of Texas, she kept a 15 16 strong focus on advancing the policies developed by thousands of delegates from across the state; after becoming State Republican 17 Executive Committeewoman for Senate District 12 in 2018, she 18 regularly toured Texas to address hundreds of grassroots clubs; she 19 advocated energetically for voters and the Republican Party 20 21 platform and worked tirelessly to educate citizens about the importance of political engagement at the local and state level; 22 23 She strongly advocated for legislation that would end the practice 24 of pediatric gender modification in the State of Texas and saw it
