## RESOLUTION

- 1 WHEREAS, Residents of Plano lost an admired civic leader with
- 2 the passing of former mayor James N. Muns on March 6, 2025, at the
- 3 age of 93; and
- WHEREAS, The son of Elvie and Claude Muns, James Muns was born
- 5 in Sweetwater on January 6, 1932; he graduated from Sweetwater High
- 6 School and earned a bachelor's degree in business administration
- 7 from Abilene Christian University; while attending ACU, he was a
- 8 member of the undefeated 1950 Wildcat Football team, and he
- 9 considered their victory in the Refrigerator Bowl one of the
- 10 defining moments of his life; and
- WHEREAS, In 1953, Mr. Muns began a 35-year tenure with Wyatt
- 12 Food Stores as a manager of its Fort Worth locations; rising through
- 13 the ranks of personnel director and vice president of operations,
- 14 he played a vital role in the company's growth; in 1978, he was
- 15 named president, a role in which he oversaw the chain's expansion to
- 16 122 locations across 9 states; following its sale in 1988, he went
- 17 on to open the venture capital and investment firm Muns Enterprises
- 18 L.P., which financed a number of real estate developments and
- 19 related projects; and
- WHEREAS, Devoted to his community, Mr. Muns served on the
- 21 Plano City Council from 1981 to 1987, and he was elected mayor of
- 22 Plano in 1992; while in office, he worked to enhance the quality of
- 23 life for his fellow citizens, and he played a key role in Plano's
- 24 recognition as an All-America City; he also served as director of

- 1 the North Texas Commission, as chair of the board of trustees for
- 2 Presbyterian Hospital of Plano, and as a board member for the
- 3 Presbyterian Hospital Foundation; in 1995, he was named Plano's
- 4 Citizen of the Year; and
- 5 WHEREAS, A man of strong faith, Mr. Muns was a church elder at
- 6 Walnut Hill Church of Christ in Dallas and Pitman Creek Church of
- 7 Christ in Plano; in his leisure hours, he enjoyed playing golf, snow
- 8 skiing, and traveling, and he was an exceptionally skilled
- 9 woodworker; and
- 10 WHEREAS, In all his endeavors, Mr. Muns benefited from the
- 11 love and support of his wife, Betty Bell, with whom he shared a
- 12 rewarding union that spanned more than seven decades until her
- 13 death in 2024; he was the proud father of four children, Kathy,
- 14 Marla, Greg, and John, and with the passing years, he had the
- 15 pleasure of seeing his treasured family grow to include 12
- 16 grandchildren and 29 great-grandchildren; and
- 17 WHEREAS, An engaged citizen, a devoted family man, and an
- 18 admired business and community leader, James Muns leaves behind a
- 19 legacy of good works that will long resonate in the Plano community;
- 20 now, therefore, be it
- 21 RESOLVED, That the House of Representatives of the 89th Texas
- 22 Legislature hereby pay tribute to the life of James  $N.\$ Muns and
- 23 extend sincere condolences to all who mourn his passing; and, be it

- 25 RESOLVED, That an official copy of this resolution be
- 26 prepared for his family and that when the Texas House of
- 27 Representatives adjourns this day, it do so in memory of James Muns.
