5	SECTION 1. Sections $29.153(a-1)$, (b), (c), (d), and (f),
6	Education Code, are amended to read as follows:
7	(a-1) A district shall offer prekindergarten classes to any
8	<pre>child [if the district identifies 15 or more children] who is [are</pre>
9	eligible under Subsection (b) and are] at least four years of age.
10	A school district may offer prekindergarten classes if the district
11	identifies 15 or more [eligible] children who are eligible under
12	Subsection (b)(1) [at least three years of age]. A district may not
13	charge tuition for a prekindergarten class offered under this
14	section.
15	(b) A child is eligible for enrollment in a prekindergarten
16	class under this section if the child is:
17	(1) at least three years of age and:
18	$\overline{(A)}$ [$\overline{(1)}$] is unable to speak and comprehend the

- 4 (d) Subject to Subsections (d-1) and (d-2), on application
- 5 of a district, the commissioner shall exempt a district from the

- 2 SECTION 3. Section 29.1532(c), Education Code, is amended
- 3 to read as follows:
- 4 (c) A school district that offers prekindergarten classes
- 5 shall include the following information in the district's Public
- 6 Education Information Management System (PEIMS) report:
- 7 (1) demographic information, as determined by the
- 8 commissioner, on students enrolled in district and campus
- 9 prekindergarten classes, including the number of students who are
- 10 eligible for classes under <u>Sections 29.153(b)(1) and (f)</u> [Section
- 11 $\frac{29.153}{}$;
- 12 (2) the numbers of half-day and full-day
- 13 prekindergarten classes offered by the district and campus;
- 14 (3) the number of half-day prekindergarten classes for
- 15 which the district has received an exemption from full-day
- 16 operation under Section 29.153(d);
- 17 (4) the sources of funding for the prekindergarten
- 18 classes;
- 19 (5) the class size and ratio of instructional staff to
- 20 students for each prekindergarten program class offered by the
- 21 district and campus;
- 22 (6) if the district elects to administer an assessment
- 23 instrument under Section 29.169 to students enrolled in district
- 24 and campus prekindergarten program classes, a description and the
- 25 results of each type of assessment instrument; and
- 26 (7) curricula used in the district's prekindergarten
- 27 program classes.

- 1 SECTION 4. This Act applies beginning with the 2025-2026
- 2 school year.
- 3 SECTION 5. This Act takes effect immediately if it receives
- 4 a vote of two-thirds of all the members elected to each house, as
- 5 provided by Section 39, Article III, Texas Constitution. If this
- 6 Act does not receive the vote necessary for immediate effect, this
- 7 Act takes effect September 1, 2025.
