5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Chapter 32, Human Resources Code, is amended by
7	adding Subchapter H to read as follows:
8	SUBCHAPTER H. EXPANSION OF ELIGIBILITY FOR MEDICAL ASSISTANCE
9	Sec. 32.351. EXPANDED ELIGIBILITY FOR MEDICAL ASSISTANCE
10	UNDER PATIENT PROTECTION AND AFFORDABLE CARE ACT. (a)
11	Notwithstanding any other law, the commission shall provide medical
12	assistance to all individuals who apply for that assistance and for
13	whom federal matching funds are available under the Patient
14	Protection and Affordable Care Act (Pub. L. No. 111-148), as
15	amended by the Health Care and Education Reconciliation Act of 2010
16	(Pub. L. No. 111-152), to provide that assistance.
17	(b) The executive commissioner shall adopt rules regarding
18	the provision of medical assistance as required by this section.
19	Sec. 32.352. ANNUAL REPORT ON EXPANDED ELIGIBILITY FOR
20	MEDICAL ASSISTANCE. Not later than December 1 of each year, the
21	commission shall report to the governor, the lieutenant governor,
22	the speaker of the house of representatives, and the standing

- 11 SECTION 2. Section 32.351, Human Resources Code, as added
- 12 by this Act, applies only to an initial determination or
- 13 recertification of eligibility of an individual for medical
- 14 assistance under Chapter 32, Human Resources Code, made on or after
- 15 January 1, 2026, regardless of the date the individual applied for
- 16 that assistance.
- 17 SECTION 3. As soon as possible after the effective date of
- 18 this Act, the executive commissioner of the Health and Human
- 19 Services Commission shall take all necessary actions to expand
- 20 eligibility for medical assistance under Chapter 32, Human
- 21 Resources Code, in accordance with Section 32.351, Human Resources
- 22 Code, as added by this Act, including notifying appropriate federal
- 23 agencies of that expanded eligibility. If before implementing any
- 24 provision of this Act a state agency determines that any other
- 25 waiver or authorization from a federal agency is necessary for
- 26 implementation of that provision, the agency affected by the
- 27 provision shall request the waiver or authorization and may delay

- 1 implementing that provision until the waiver or authorization is
- 2 granted.
- 3 SECTION 4. This Act takes effect January 1, 2026, but only
- 4 if the constitutional amendment proposed by the 89th Legislature,
- 5 Regular Session, 2025, requiring the state to expand eligibility
- 6 for Medicaid to all individuals for whom federal matching funds are
- 7 available under the federal Patient Protection and Affordable Care
- 8 Act is approved by the voters. If that amendment is not approved by
- 9 the voters, this Act has no effect.
