16 SECTION 2. The change in law made by this Act applies only 17 to the denial of a motion to dismiss ordered on or after the 18 effective date of this Act. A denial of a motion to dismiss ordered 19 before the effective date of this Act is governed by the law 20 applicable to the denial immediately before the effective date of 21 this Act, and that law is continued in effect for that purpose.

SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2025.
