3 Sec. 24B.006. NONEXCLUSIVITY. This chapter does not limit:
 4 (1) the rights of a property owner; or
 5 (2) the authority of a law enforcement officer to

6 arrest an unauthorized occupant of a dwelling for trespassing,
7 vandalism, theft, or another offense.

SECTION 4. Section 28.03, Penal Code, as amended by this 8 Act, applies only to an offense committed on or after the effective 9 date of this Act. An offense committed before the effective date of 10 this Act is governed by the law in effect on the date the offense was 11 committed, and the former law is continued in effect for that 12 purpose. For purposes of this section, an offense was committed 13 before the effective date of this Act if any element of the offense 14 15 occurred before that date.

SECTION 5. This Act takes effect September 1, 2025.
