5	SECTION 1. Subchapter A, Chapter 17, Utilities Code, is
6	amended by adding Section 17.011 to read as follows:
7	Sec. 17.011. SHARING PROPRIETARY CUSTOMER INFORMATION. (a)
8	In this section, "proprietary customer information" means any
9	identifying information compiled by a retail electric provider
10	about an individual customer that may be used for communication
11	regarding emergencies, billing, or service-related matters,
12	<pre>including the customer's:</pre>
13	(1) name;
14	(2) telephone number;
15	(3) e-mail address; or
16	(4) home address.
17	(b) An electric utility providing electric delivery
18	services for a retail electric provider may request from the retail
19	electric provider any proprietary customer information reasonably
20	necessary for the electric utility to communicate with a customer
21	regarding an emergency affecting service, an interruption of
22	service, or restoration of service. The retail electric provider
23	shall provide to the electric utility the proprietary customer

information not later than 48 hours after the request is made. The

- 1 retail electric provider is not required to obtain a prior
- 2 verifiable authorization from the customer before complying with
- 3 this subsection.
- 4 (c) Notwithstanding Section 39.157(d)(4), an electric
- 5 utility may provide the proprietary customer information to another
- 6 person without prior verifiable authorization from the customer as
- 7 necessary for communication with the customer regarding an
- 8 emergency affecting service, an interruption of service, or
- 9 restoration of service.
- 10 (d) An electric utility or another person who obtains
- 11 proprietary customer information under this section:
- 12 (1) shall, for purposes of protecting the
- 13 confidentiality, integrity, and accessibility of the information,
- 14 establish, implement, and maintain reasonable administrative,
- 15 technical, and physical data security practices that are
- 16 appropriate to the volume and nature of the information at issue,
- 17 including encryption and secure data storage; and
- 18 (2) may not retain the information for longer than
- 19 reasonably necessary to communicate with the customer regarding an
- 20 emergency affecting service, an interruption of service, or
- 21 restoration of service.
- (e) Except as provided by Subsection (f), Subchapter B,
- 23 Chapter 15, does not apply to a violation of this section.
- 24 (f) Section 15.021 applies to a violation of this section.
- 25 (g) This section does not affect the application of Chapter
- 26 541, Business & Commerce Code, to a person that is not an electric
- 27 utility or a retail electric provider.
