## A BILL TO BE ENTITLED

1	AN ACT
2	relating to an attendance policy adopted by public schools to
3	prevent truancy.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter C, Chapter 25, Education Code, is
6	amended by adding Section 25.0916 to read as follows:
7	Sec. 25.0916. ATTENDANCE POLICY. (a) In this section,
8	"parent" includes a person standing in parental relation.
9	(b) The board of trustees of each school district and the
10	governing body of each open-enrollment charter school shall adopt
11	and implement an attendance policy to:
12	(1) inform students and parents regarding the
13	<pre>importance of regular attendance; and</pre>
14	(2) provide appropriate supports to students who fail
15	to regularly attend school.
16	(c) An attendance policy adopted under this section must:
17	(1) describe the benefits of regular attendance;
18	(2) describe the consequences of failing to regularly
19	attend school, including the negative effects on:
20	(A) a student's academic progress; and
21	(B) a student and the student's family as a
22	result of referral to a truancy court for truant conduct under
23	Section 65.003(a), Family Code;
24	(3) provide for a parent of a student enrolled in the

- 1 district or school to elect to receive notifications of the
- 2 student's absence from school for a day or part of a day, regardless
- 3 of whether the student's absence is excused or unexcused, through:
- 4 (A) e-mail or text message, if the district or
- 5 school has the capability to send notifications through those
- 6 methods; or
- 7 (B) first class mail, if the district or school
- 8 does not have the capability to send notifications as provided by
- 9 Paragraph (A);
- 10 (4) provide for a meeting between a parent of a student
- 11 enrolled in the district or school and a school counselor,
- 12 principal, or appropriate administrator when the student becomes at
- 13 risk for engaging in truant conduct under Section 65.003, Family
- 14 Code, as provided by the policy, to discuss the student's behavior
- and any conditions at the student's home that may be contributing to
- 16 the student's failure to attend school;
- 17 (5) if a parent of a student enrolled in the district
- 18 or school fails to attend a meeting described by Subdivision (4),
- 19 authorize the school attendance officer to make a home visit or
- 20 otherwise contact the parent in the manner described by Section
- 21 <u>25.091</u> to investigate the student's behavior and living conditions
- 22 and report the attendance officer's findings to the district or
- 23 school; and
- 24 (6) establish guidelines to identify a student in need
- 25 of additional support and to refer the student to in-school or
- 26 out-of-school services aimed at addressing the student's failure to
- 27 regularly attend school.

- 1 (d) At the beginning of each school year, each school
- 2 district or open-enrollment charter school shall provide a copy of
- 3 the attendance policy adopted under this section to the parent of
- 4 <u>each student enrolled in the district or school.</u>
- 5 SECTION 2. This Act applies beginning with the 2025-2026
- 6 school year.
- 7 SECTION 3. This Act takes effect immediately if it receives
- 8 a vote of two-thirds of all the members elected to each house, as
- 9 provided by Section 39, Article III, Texas Constitution. If this
- 10 Act does not receive the vote necessary for immediate effect, this
- 11 Act takes effect September 1, 2025.
