(a) The division shall require each department to:

2 (1) keep financial and statistical records determined3 necessary by the division;

4 (2) submit <u>the department's budget and</u> [a] strategic
5 plan and all supporting information requested by the division;

6 (3) present data requested by the division as 7 necessary to determine the amount of state aid for which the 8 department is eligible;

9 (4) submit periodic financial audits and statistical 10 reports to the division; and

(5) submit to the Department of Public Safety the full name, address, date of birth, social security number, and driver's license number of each person restricted to the operation of a motor vehicle equipped with a device that uses a deep-lung breath analysis mechanism to make impractical the operation of the motor vehicle if ethyl alcohol is detected in the breath of the restricted operator.

SECTION 4. The heading to Section 509.007, Government Code, is amended to read as follows:

SECTION 5. Section 509.007, Government Code, is amended by amending Subsection (a) and adding Subsection (a-1) to read as follows:

(a) The division shall require as a condition to payment of
state aid to a department or county under Section 509.011 that:

(2) the department's budget and plan be approved by the
 division [be submitted for the department. The department shall
 submit the plan required by this subsection. A department may not

 department].
 (a-1) A [The] department shall submit the department's

8 <u>budget for the next state fiscal biennium and</u> a revised <u>strategic</u> 9 plan to the division each even-numbered year not later than March 1. 10 <u>The department's budget or strategic</u> [A] plan may be amended at any 11 time with the approval of the division.
