## A BILL TO BE ENTITLED

1	AN ACT
2	relating to the public information law.
3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
4	SECTION 1. Section 552.221, Government Code, is amended by
5	adding Subsections (f) and (g) to read as follows:
6	(f) If the governmental body determines it has no
7	information responsive to a request for information, the officer
8	for public information shall notify the requestor in writing not
9	later than the 10th business day after the date the request is
10	received.
11	(g) If a governmental body determines the requested
12	information is subject to a previous determination that permits or
13	requires the governmental body to withhold the requested
14	information, the officer for public information shall, not later
15	than the 10th business day after the date the request is received:
16	(1) notify the requestor in writing that the
17	information is being withheld; and
18	(2) identify in the notice the specific previous
19	determination the governmental body is relying on to withhold the
20	requested information.
21	SECTION 2. Section 552.261, Government Code, is amended by

- 25 general issues an opinion under Subsection (b) regarding
- 26 information requested under this chapter:
- 27 (1) [provide the requestor of the information an

- 2 the estimate is required by Section 552.2615;

- 4 (A) take the following actions if the
- 5 governmental body determines that it is able to disclose the

- 7 (i) provide a written certified notice to
- 8 the requestor and the attorney general that it is impractical or
- 9 impossible for the governmental body to produce the information
- 10 within a reasonable period of time;
- 11 (ii) include in the notice the date and hour
- 12 that the governmental body will disclose the information to the
- 13 requestor, which may not be later than the 15th business day after
- 14 the date the governmental body provides the notice; and
- 15 (iii) produce the information at the date
- 16 and time included in the notice; or
- 17 (B) take the following actions if the
- 18 governmental body determines that it is unable to disclose the
- 19 information in a single batch:

- (iii) provide a written certified notice to
- 3 the requestor and the attorney general when each subsequent batch
- 4 of information is disclosed to the requestor of the date and hour
- 5 that the governmental body will disclose the next batch of
- 6 information to the requestor, which may not be later than the 15th
- 7 business day after the date the governmental body provides the
- 8 notice; and
- 9 (iv) produce the requested information at
- 10 each date and time included in a notice;
- 11  $\underline{(2)}$  [(3)] produce the information if it is required to
- 12 be produced;
- (3)  $[\frac{(4)}{(4)}]$  notify the requestor in writing that the
- 14 governmental body is withholding the information as authorized by
- 15 the opinion; or
- (4)  $[\frac{(5)}{(5)}]$  notify the requestor in writing that the
- 17 governmental body has filed suit against the attorney general under
- 18 Section 552.324 regarding the information.
- 19 SECTION 4. Section 552.323, Government Code, is amended to
- 20 read as follows:
- Sec. 552.323. ASSESSMENT OF COSTS OF LITIGATION AND
- 22 REASONABLE ATTORNEY FEES. (a) Except as provided by Subsections
- 23 (b) and (c), in [In] an action brought under Section 552.321, [or]
- 24 552.3215, 552.324, or 552.325, the court shall assess costs of
- 25 litigation and reasonable attorney fees incurred by a plaintiff or
- 26 intervening requestor:
- 27 (1) who substantially prevails; or

1 (2) to whom a governmental body voluntarily releases the requested information, unless before suit is filed: 2 3 (A) the body releases the information; or 4 (B) the body certifies a date and hour within a reasonable time when the information will be available for 5 inspection or duplication. 6 7 (b) The [ rexcept that the ] court may not assess [those] 8 costs or [and] fees against a governmental body under Subsection (a) if the court finds that the governmental body acted in 9 reasonable reliance on: 10 11 (1) a judgment or an order of a court applicable to the 12 governmental body; the published opinion of an appellate court; or 13 14 a written decision of the attorney general, 15 including a decision issued under Subchapter G or an opinion issued under Section 402.042. 16 17 (c) Notwithstanding Subsection (a), in an action brought under Section 552.325 by a person or entity other than a 18 19 governmental body or officer for public information, the court shall assess costs of litigation and reasonable attorney fees 20 21 incurred by an intervening requestor if the intervening requestor 22 substantially prevails. 23 [(b) In an action brought under Section 552.324, the court 24 may not assess costs of litigation or reasonable attorney's fees

incurred by a plaintiff or defendant who substantially prevails

unless the court finds the action or the defense of the action was

- 2 governmental body had a reasonable basis in law and whether the
- 3 litigation was brought in good faith.
- 4 SECTION 5. The heading to Subchapter H, Chapter 552,
- 5 Government Code, is amended to read as follows:
- 6 SUBCHAPTER H. CIVIL ENFORCEMENT; COMPLAINT
- 7 SECTION 6. Subchapter H, Chapter 552, Government Code, is
- 8 amended by adding Section 552.328 to read as follows:
- 9 Sec. 552.328. FAILURE TO RESPOND TO REQUESTOR. (a) If a
- 10 governmental body fails to respond to a requestor as required by
- 11 Section 552.221, the requestor may send a written complaint to the
- 12 attorney general.
- 13 (b) The complaint must include:
- 14 (1) the original request for information; and
- 15 (2) any correspondence received from the governmental
- 16 body in response to the request.
- 17 (c) If the attorney general determines the governmental
- 18 body improperly failed to comply with Section 552.221 in connection
- 19 with a request for which a complaint is made under this section:
- 20 (1) the attorney general shall notify the governmental
- 21 body in writing and require the governmental body to complete open
- 22 records training not later than six months after receiving the
- 23 <u>notification;</u>
- 24 (2) the governmental body may not assess costs to the
- 25 requestor for producing information in response to the request; and
- 26 (3) if the governmental body seeks to withhold
- 27 information in response to the request, the governmental body must:

- 1 (A) request an attorney general decision under
- 2 Section 552.301 not later than the fifth business day after the date
- 3 the governmental body receives the notification under Subdivision
- 4 (1); and
- 5 (B) release the requested information unless
- 6 there is a compelling reason to withhold the information.
- 7 SECTION 7. The changes in law made by this Act apply only to
- 8 a request for information that is received by a governmental body or
- 9 an officer for public information on or after the effective date of
- 10 this Act. A request for information that was received before the
- 11 effective date of this Act is governed by the law in effect on the
- 12 date the request was received, and the former law is continued in
- 13 effect for that purpose.
- 14 SECTION 8. This Act takes effect September 1, 2025.
