A BILL TO BE ENTITLED

1	AN ACT
2	relating to the revocation of an occupational license from certain
3	license holders and the issuance of a provisional occupational
4	license to certain applicants with criminal convictions.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Section 53.021, Occupations Code, is amended by
7	adding Subsection (a-2) and amending Subsection (b) to read as
8	follows:
9	(a-2) A licensing authority may revoke a license holder's
10	license on the grounds of the license holder's imprisonment
11	following a felony conviction.
12	(b) A license holder's license shall be revoked on the
13	license holder's imprisonment following a:
14	(1) felony conviction for:
15	(A) an offense that directly relates to the
16	duties and responsibilities of the licensed occupation;
17	(B) an offense listed in Article 42A.054, Code of
18	Criminal Procedure; or
19	(C) a sexually violent offense, as defined by
20	Article 62.001, Code of Criminal Procedure;
21	(2) [7] felony community supervision revocation;
22	(3) [7] revocation of parole; [7] or
23	(4) revocation of mandatory supervision.
24	SECTION 2. Section 53.0211, Occupations Code, is amended by

- 1 amending Subsections (b) and (c) and adding Subsections (b-1) and
- 2 (h) to read as follows:
- 3 (b) Notwithstanding any law other than Subsection (a) and
- 4 unless the applicant has been convicted of an offense described by
- 5 Section 53.021(a), a licensing authority shall issue to an
- 6 otherwise qualified applicant who has been convicted of an offense:
- 7 (1) the license for which the applicant applied; or
- 8 (2) a provisional license <u>under Subsection (b-1) valid</u>
- 9 for a term of 12 months [described by Subsection (c)].
- 10 (b-1) A licensing authority may issue a provisional license
- 11 to an applicant who has been convicted of an offense, including an
- 12 applicant who:
- 13 (1) is:
- 14 (A) an inmate imprisoned in the Texas Department
- 15 of Criminal Justice; or
- (B) a person released on parole or mandatory
- 17 supervision and residing at a place described by Section 508.118 or
- 18 <u>508.119</u>, Government Code; and
- 19 <u>(2) is enrolled in or has completed an educational</u>
- 20 program offered by:
- 21 (A) the Windham School District; or
- (B) an institution of higher education, as
- 23 defined by Section 61.003, Education Code.
- 24 (c) The term of a provisional license issued to an applicant
- 25 who is an inmate imprisoned in the Texas Department of Criminal
- 26 Justice begins on the date the applicant is released [A licensing
- 27 authority may issue a provisional license for a term of six months

- 1 to an applicant who has been convicted of an offense].
- 2 (h) On request of a licensing authority, the Texas
- 3 Department of Criminal Justice shall provide to the licensing
- 4 authority information regarding an applicant who is an inmate
- 5 imprisoned in the Texas Department of Criminal Justice for purposes
- 6 of determining the inmate's eligibility for a license.
- 7 SECTION 3. Section 508.313(c), Government Code, is amended
- 8 to read as follows:
- 9 (c) The department, on request or in the normal course of
- 10 official business, shall provide information that is confidential
- 11 and privileged under Subsection (a) to:
- 12 (1) the governor;
- 13 (2) a member of the board or a parole commissioner;
- 14 (3) the Criminal Justice Policy Council in performing
- 15 duties of the council under Section 413.017; [or]
- 16 (4) <u>a licensing authority requesting information</u>
- 17 concerning an inmate or releasee who has submitted an application
- 18 for an occupational license to the licensing authority; or
- 19 (5) an eligible entity requesting information for a
- 20 law enforcement, prosecutorial, correctional, clemency, or
- 21 treatment purpose.
- 22 SECTION 4. This Act takes effect immediately if it receives
- 23 a vote of two-thirds of all the members elected to each house, as
- 24 provided by Section 39, Article III, Texas Constitution. If this
- 25 Act does not receive the vote necessary for immediate effect, this
- 26 Act takes effect September 1, 2025.
