- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 26.131, Water Code, as effective until
- 7 delegation of authority under the Resource Conservation and
- 8 Recovery Act of 1976 (42 U.S.C. Section 6901 et seq.) to the
- 9 Railroad Commission of Texas, is amended by amending Subsection (b)
- 10 and adding Subsection (e) to read as follows:
- 11 (b) Except as provided by Subsections [Subsection] (d) and
- 12 (e), the Railroad Commission of Texas may issue permits for the
- 13 discharge of waste resulting from the activities described by
- 14 Subsection (a), and the discharge of waste into water in this state
- 15 resulting from those activities must meet the water quality
- 16 standards established by the commission.
- 17 (e) The commission may issue permits for the land
- 18 application of produced water resulting from activities described
- 19 by Subsection (a) that has been treated for beneficial use. The
- 20 <u>commission shall adopt standards for the land application of water</u>
- 21 under this section, including standards that prevent the pollution
- 22 of surface and subsurface water.
- SECTION 2. Section 26.131, Water Code, as effective on
- 24 delegation of authority under the Resource Conservation and

- 1 Recovery Act of 1976 (42 U.S.C. Section 6901 et seq.) to the
- 2 Railroad Commission of Texas, is amended by amending Subsection (b)
- 3 and adding Subsection (d) to read as follows:
- 4 (b) Except as provided by <u>Subsections</u> [<u>Subsection</u>] (c) <u>and</u>
- 5 (d), the Railroad Commission of Texas may issue permits for the
- 6 discharge of waste resulting from the activities described by
- 7 Subsection (a), and the discharge of waste into water in this state
- 8 resulting from those activities must meet the water quality
- 9 standards established by the commission.
- 10 (d) The commission may issue permits for the land
- 11 application of produced water resulting from activities described
- 12 by Subsection (a) that has been treated for beneficial use. The
- 13 commission shall adopt standards for the land application of water
- 14 under this section, including standards that prevent the pollution
- 15 of surface and subsurface water.
- SECTION 3. The change in law made by this Act applies only
- 17 to a permit, the application for which is filed on or after the
- 18 effective date of this Act. A permit, the application for which is
- 19 filed before the effective date of this Act, is subject to the law
- 20 in effect on the date the application is filed, and that law is
- 21 continued in effect for that purpose.
- 22 SECTION 4. This Act takes effect September 1, 2025.
