1-19 A BILL TO BE ENTITLED 1-20 AN ACT

relating to a pilot program for the safe disposal of prescription drugs, including controlled substance prescription drugs.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 442A.001, Health and Safety Code, is amended to read as follows:

Sec. 442A.001.

001. DEFINITIONS. In this chapter: "Collection receptacle" means a receptacle described by 21 C.F.R. Section 1317.75 ["Board" means State Board of Pharmacy].

(2)"Commission" means the Health and Human Services Commission.

"Controlled substance" has the meaning assigned by Section 481.002.

"Department" means the Department of State Health (4)Services.

<u>(5)</u> [<del>(3)</del>] "Pharmacy" means a facility licensed under Chapter 560, Occupations Code.

(6)  $[\frac{(4)}{1}]$  "Pilot program" means the prescription drug safe disposal pilot program established under this chapter.

(7) [(5)] "Prescription drug" has meaning assigned by Section 551.003, Occupations Code.

<u>(8)</u> [<del>(6)</del>] "Ultimate user" has the meaning assigned by 21 U.S.C. Section 802.

SECTION 2. Section 442A.002, Health and Safety Code, is amended to read as follows:

Sec. 442A.002. PRESCRIPTION DRUG SAFE DISPOSAL PILOT PROGRAM. The executive commissioner of the commission [board] by rule shall develop and implement a prescription drug safe disposal pilot program administered by the department to increase the number of <u>collection receptacles</u> [<del>locations</del>] in this state where unused, unwanted, or expired prescription drugs are collected from the public for safe disposal.

SECTION 3. Section 442A.051, Health and Safety Code, is amended to read as follows:

Sec. 442A.051. PHARMACY ELIGIBILITY. A pharmacy operating in this state may apply to the <u>department</u> [board] to participate in the pilot program if the pharmacy:

Sec. 442A.052. APPLICATION AND SELECTION PROCESSES. (a) The <u>department</u> [board] shall <u>prescribe</u> [adopt rules prescribing:

participation in the pilot program[; and [(2) evaluation and se <del>selection criteria</del> processes].

The department [board] shall give priority for [<del>(b)</del>] participation in the pilot program to a pharmacy applicant that:

(1) does not collect unused ultimate user prescription drugs under 21 C.F.R. Part 1317 at the time the applicant submits the application; or

(2) is located in a rural or underserved area the

[must] submit one [an] application to apply for the program for of the locations, provided the application contains information specific to each location, including the physical address, phone number, location name, and pharmacy manager's name [<del>for each</del> location]. Each location is separately evaluated prioritization under Subsection (a).

SECTION 5. Section 442A.053(b), Health and Safety Code, is amended to read as follows:

(b) Controlled substance prescription drugs<u>,</u> [<del>and</del>] noncontrolled substance prescription drugs  $\underline{\underline{\hspace{0.5cm}}}$  and over-the-counter <u>drugs</u> may be collected together and comingled.

SECTION 6. Section 442A.055, Health and Safety Code, is amended to read as follows:

MANAGEMENT; Sec. 442A.055. PHARMACY RECORDS. participating pharmacy is responsible for the daily management and recordkeeping of the pharmacy's prescription drug safe disposal program in accordance with the pharmacy's United States Drug Enforcement Administration registration [and board rules].

SECTION 7. The heading to Subchapter C, Chapter 442A, Health and Safety Code, is amended to read as follows:

SUBCHAPTER C. DEPARTMENT [BOARD] DUTIES

SECTION 8. Sections 442A.101(a) and (b), Health and Safety Code, are amended to read as follows:

- (a) The  $\underline{\text{department}}$  [ $\underline{\text{board}}$ ] shall assist each pharmacy participating in the pilot program, including by paying [ $\underline{\text{the costs}}$ <del>of</del>]:
- the costs of maintaining one collection receptacle at each participating pharmacy location and destroying through incineration of the receptacle's full inner liner containing the prescription drugs <u>collected</u> [<u>deposited</u>] in the receptacle; <u>and</u>
- one-time fee to offset the initial costs (2) a program participation [ordering and distributing pre-addressed, return postage paid mail-back envelopes from mail-back program and destroying through incineration the returned mail-back envelopes containing the collected prescription drugs; and

(3) other operational needs the board determines appropriate].

(b) The department may contract with a reverse distributor registered with the United States Drug Enforcement Administration to install the collection receptacles at participating pharmacy locations and to treat at an incineration facility registered with the United States Drug Enforcement Administration the drugs collected in the receptacles [board:

[<del>(1) shall directly reimburse a participating</del> pharmacy for costs the pharmacy incurs under Subsection (a); and

[(2) may not reimburse a participating pharmacy for using a third-party incineration facility unless the facility is appropriately registered with the United States Drug

Sec. 442A.102. COMMUNITY OUTREACH. (a) The department [board] shall:

- (1)develop and distribute educational outreach for the public about the materials availability of safe prescription drug disposal in this state;
- (2) post the materials on the <u>department's</u> [board's] Internet website; [and]
- (3) provide the materials to other state agencies, including the Texas State Board of Pharmacy, for those agencies toconduct the community outreach; and

(4) create education materials for voluntary use by a

participating pharmacy.

The educational outreach materials must be in English, Spanish, and for specific areas of this state as the department [board] determines appropriate, another language spoken by a substantial portion of the area's residents.

SECTION 10. Section 442A.103, Health and Safety Code, is amended to read as follows:

Sec. 442A.103. REPORT. Not later than December 1 of each even-numbered year, the <u>department</u> [board] shall submit to the governor and the legislature a report that:

(1) summarizes the results of the pilot program, including:

(B) the estimated amount of prescription drugs collected by participating pharmacies under the program, measured

(E) [<del>(D)</del>] description of the <u>department's</u> а [board's] educational efforts and outcomes; and

(2) recommends whether the pilot program should continue, be expanded, or terminate or whether the <u>department</u> [board] should permanently implement a prescription drug safe should disposal program.

SECTION 11. Section 442A.151, Health and Safety Code, is amended to read as follows:

Sec. 442A.151. FUNDING. (a) Money contained in the opioid abatement account established under Section 403.505, Government the <u>department</u> [board] to fund the pilot program established under this chapter.

(b) The department [board] may collect gifts, grants, and donations to fund the program.

SECTION 12. Sections 442A.056 and 442A.101(c), Health and Safety Code, are repealed.
