16	SECTION 2. Subchapter D, Chapter 32, Insurance Code, is

18	Sec. 32.1025. CLAIMS CONTACT INFORMATION. (a)
19	Notwithstanding Section 32.101, this section applies to each

- Sec. 32.104. DUTIES OF INSURER. (a) On the request of the
- 18 department, an insurer, including an insurer to which Section
- 19 <u>32.1025</u> applies, shall provide to the department any information
- 20 the department and the office of public insurance counsel determine
- 21 is reasonable or necessary to fulfill the department's and the
