S.B. No. 2611

A BILL TO BE ENTITLED

AN ACT

relating to the status of certain documents or instruments concerning real or personal property; creating the criminal offenses of real property theft and real property fraud and establishing a statute of limitations for those offenses; harmonizing other statute of limitations provisions; increasing a criminal penalty.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Article 12.01, Code of Criminal Procedure, as amended by Chapters 93 (S.B. 1527), 118 (H.B. 467), 127 (H.B. 1207), 422 (H.B. 1769), 520 (H.B. 3025), 689 (H.B. 1506), 704 (H.B. 2019), 709 (H.B. 2190), 768 (H.B. 4595), 830 (H.B. 2187), 885 (H.B. 4635), and 1041 (S.B. 129), Acts of the 88th Legislature, Regular Session, 2023, is reenacted and amended to read as follows:

Art. 12.01. FELONIES. Except as provided in Articles 12.015 and 12.03, felony indictments may be presented within these limits, and not afterward:

(1) no limitation:

(A) murder and manslaughter;

(B) sexual assault under Section 22.011(a)(2), Penal Code, or aggravated sexual assault under Section 22.021(a)(1)(B), Penal Code;

(C) sexual assault, if:

(i) during the investigation of the offense

biological matter is collected and the matter:

(a) has not yet been subjected to forensic DNA testing; or

(b) has been subjected to forensic DNA testing and the testing results show that the matter does not match the victim or any other person whose identity is readily ascertained; or

(ii) probable cause exists to believe that the defendant has committed the same or a similar sex offense against five or more victims;

(D) continuous sexual abuse of young child or disabled individual under Section 21.02, Penal Code;

(E) indecency with a child under Section 21.11, Penal Code;

(F) an offense involving leaving the scene of a collision under Section 550.021, Transportation Code, if the collision resulted in the death of a person;

(G) trafficking of persons under Section 20A.02(a)(7) or (8), Penal Code;

(H) continuous trafficking of persons under Section 20A.03, Penal Code;

(I) compelling prostitution under Section 43.05(a)(2) or (3), Penal Code; ~~or~~

(J) tampering with physical evidence under Section 37.09(a)(1) or (d)(1), Penal Code, if:

(i) the evidence tampered with is a human corpse, as defined by that section; or

1 (ii) the investigation of the offense shows  
2 that a reasonable person in the position of the defendant at the  
3 time of the commission of the offense would have cause to believe  
4 that the evidence tampered with is related to a criminal homicide  
5 under Chapter 19, Penal Code;

6 (K) [~~(J)~~] interference with child custody under  
7 Section 25.03(a)(3), Penal Code; or

8 (L) [~~(J)~~] burglary under Section 30.02, Penal  
9 Code, if:

10 (i) the offense is punishable under  
11 Subsection (d) of that section because the defendant entered a  
12 habitation with the intent to commit an offense under Section  
13 22.011 or 22.021, Penal Code; and

14 (ii) during the investigation of the  
15 offense biological matter is collected and the matter:

16 (a) has not yet been subjected to  
17 forensic DNA testing; or

18 (b) has been subjected to forensic DNA  
19 testing and the testing results show that the matter does not match  
20 the victim or any other person whose identity is readily  
21 ascertained;

22 (2) ten years from the date of the commission of the  
23 offense:

24 (A) theft of any estate, real, personal or mixed,  
25 by an executor, administrator, guardian or trustee, with intent to  
26 defraud any creditor, heir, legatee, ward, distributee,  
27 beneficiary or settlor of a trust interested in such estate;

(B) theft by a public servant of government property over which the public servant exercises control in the public servant's official capacity;

(C) forgery or the uttering, using, or passing of forged instruments;

(D) injury to an elderly or disabled individual punishable as a felony of the first degree under Section 22.04, Penal Code;

(E) sexual assault, except as provided by Subdivision (1) or (9) [~~(8)~~];

(F) arson;

(G) trafficking of persons under Section 20A.02(a)(1), (2), (3), or (4), Penal Code; [~~or~~]

(H) compelling prostitution under Section 43.05(a)(1), Penal Code;

(I) real estate theft under Section 31.22, Penal Code; or

(J) real estate fraud under Section 32.56, Penal Code;

(3) seven years from the date of the commission of the offense:

(A) misapplication of fiduciary property or property of a financial institution;

(B) fraudulent securing of document execution;

(C) a felony violation under Chapter 162, Tax Code;

(D) false statement to obtain property or credit

1 under Section 32.32, Penal Code;

2 (E) money laundering;

3 (F) credit card or debit card abuse under Section

4 32.31, Penal Code;

5 (G) fraudulent use or possession of identifying

6 information under Section 32.51, Penal Code;

7 (H) exploitation of a child, elderly individual,

8 or disabled individual under Section 32.53, Penal Code;

9 (I) health care fraud under Section 35A.02, Penal

10 Code;

11 (J) bigamy under Section 25.01, Penal Code,

12 except as provided by Subdivision (7); or

13 (K) possession or promotion of child pornography

14 under Section 43.26, Penal Code;

15 (4) five years from the date of the commission of the

16 offense:

17 (A) theft or robbery;

18 (B) except as provided by Subdivision (5),

19 kidnapping;

20 (C) [~~(B-1)~~] except as provided by Subdivision

21 (1) or (5), burglary;

22 (D) [~~(C)~~] injury to an elderly or disabled

23 individual that is not punishable as a felony of the first degree

24 under Section 22.04, Penal Code;

25 (E) [~~(D)~~] abandoning or endangering an [~~a~~

26 ~~child,~~] elderly [~~individual,~~] or disabled individual;

27 (F) [~~(E)~~] insurance fraud;

1            (G) [~~(F)~~] assault under Section 22.01, Penal  
2 Code, if the assault was committed against a person whose  
3 relationship to or association with the defendant is described by  
4 Section 71.0021(b), 71.003, or 71.005, Family Code;

5            (H) [~~(G)~~] continuous violence against the family  
6 under Section 25.11, Penal Code; or

7            (I) [~~(H)~~] aggravated assault under Section  
8 22.02, Penal Code;

9            (5) if the investigation of the offense shows that the  
10 victim is younger than 17 years of age at the time the offense is  
11 committed, 20 years from the 18th birthday of the victim of one of  
12 the following offenses:

13            (A) kidnapping under Section 20.03, Penal Code,  
14 or aggravated kidnapping under Section 20.04, Penal Code; or

15            (B) subject to Subdivision (1)(L) [~~(1)(J)~~],  
16 burglary under Section 30.02, Penal Code, if the offense is  
17 punishable under Subsection (d) of that section because the  
18 defendant entered a habitation with the intent to commit an offense  
19 described by Subdivision (1)(B) or (D) of this article or Paragraph  
20 (A) of this subdivision;

21            (6) 20 years from the 18th birthday of the victim of  
22 one of the following offenses:

23            (A) trafficking of a child [~~persons~~] under  
24 Section 20A.02(a)(5) or (6), Penal Code; or

25            (B) sexual performance by a child under Section  
26 43.25, Penal Code;

27            (7) ten years from the 18th birthday of the victim of

the offense:

(A) injury to a child under Section 22.04, Penal Code;

(B) bigamy under Section 25.01, Penal Code, if the investigation of the offense shows that the person, other than the legal spouse of the defendant, whom the defendant marries or purports to marry or with whom the defendant lives under the appearance of being married is younger than 18 years of age at the time the offense is committed; or

(C) ~~[(D)]~~ abandoning or endangering a child;

(8) ~~[(7)]~~ ten years from the date the offense was discovered: trafficking of a disabled individual under Section 20A.02(a)(5) or (6), Penal Code;

(9) ~~[(8)]~~ two years from the date the offense was discovered: sexual assault punishable as a state jail felony under Section 22.011(f)(2), Penal Code; or

(10) ~~[(9)]~~ three years from the date of the commission of the offense: all other felonies.

SECTION 2. Title 1, Code of Criminal Procedure, is amended by adding Chapter 5C to read as follows:

CHAPTER 5C. PROCEDURES FOR REAL PROPERTY THEFT AND FRAUD

Art. 5C.001. VERDICT; JUDGMENT. (a) If an offense under Section 31.22 or Section 32.56, Penal Code, involves more than one parcel of real property:

(1) for a case determined by a trial by jury:

(A) the verdict form shall clearly identify each parcel of real property by street address or legal description of

1 the real property;

2 (B) the jury foreperson shall indicate whether  
3 the jury unanimously finds that the parcel of real property is  
4 included in the conduct constituting the offense; and

5 (C) the judgment must reflect the jury's verdict  
6 for each parcel of real property that the jury unanimously finds to  
7 be included in the conduct constituting the offense;

8 (2) for a case determined by a judge without a jury:

9 (A) the judge in rendering the verdict shall  
10 state, for each parcel of real property, whether the judge finds the  
11 property to be included in the conduct constituting the offense;  
12 and

13 (B) the judgment must reflect the judge's finding  
14 for each parcel of real property that the judge finds to be included  
15 in the conduct constituting the offense; and

16 (3) for a case determined based on the defendant's  
17 plea, if the indictment does not clearly identify each parcel of  
18 real property alleged to be included in the conduct constituting  
19 the offense, the prosecutor shall provide that information to the  
20 court. The court shall include the information in the judgment.

21 (b) A judgment of conviction entered for an offense under  
22 Section 31.22 or Section 32.56, Penal Code, must include:

23 (1) the street address or legal description of the  
24 real property; and

25 (2) for each document that relates to the real  
26 property that is the subject of the offense and that is recorded in  
27 the real property records of the county, the identifying reference



number assigned to that document by the county clerk.

Art. 5C.002. JUDGMENT TO BE FILED WITH COUNTY CLERK. Not later than the 10th day after the date the court enters a judgment for an offense under Section 31.22 or Section 32.56, Penal Code, the prosecutor or the court clerk, as determined by local court rule, shall file with the county clerk:

(1) a certified copy of the judgment for recording in the real property records of the county where the real property that is the subject of the offense is located;

(2) a statement explaining the filing; and

(3) if the judgment does not comply with Article 5C.001(b), a certified copy of the indictment.

Art. 5C.003. EFFECT OF NONCOMPLIANCE ON JUDGMENT. A judgment for an offense under Section 31.22 or Section 32.56, Penal Code, is not invalid solely because the judgment fails to comply with Article 5C.001(b) or 5C.002.

SECTION 3. Chapter 42, Code of Criminal Procedure, is amended by adding Article 42.0376 to read as follows:

Art. 42.0376. MANDATORY RESTITUTION FOR REAL ESTATE THEFT.

(a) Except as provided by Subsection (b) and subject to Subsection (c), the court shall order a defendant convicted of an offense under Section 31.22, Penal Code, to pay restitution, as applicable:

(1) for an offense under Section 31.22(b)(1), to the owner of the real property or nonpossessory interest in real property that is the subject of the offense in an amount equal to the value of the real property or nonpossessory interest;

(2) for an offense under Section 31.22(b)(2), to the

owner of the benefit that is the subject of the offense in an amount equal to the value of the benefit;

(3) to a title company or insurer that paid a claim based on the conduct constituting the offense, in an amount equal to the value of the payment made by the title company or insurer; or

(4) to the owner of the real property or nonpossessory interest in real property or the owner of the benefit in an amount equal to, as applicable:

(A) the value of losses incurred as the result of the conduct constituting the offense, including loss of personal property located on or in the real property that is the subject of the offense;

(B) the cost of repairing damage caused by or resulting from the conduct constituting the offense; or

(C) reasonable attorney's fees and court costs related to an action brought to quiet title to or dispute the conveyance or possession of the real property that is the subject of the offense.

(b) The court may not order a defendant convicted of an offense under Section 31.22(b)(1), Penal Code, to pay restitution if, before judgment is entered in the case, the defendant:

(1) with respect to the real property or nonpossessory interest in real property that is the subject of the offense, executes a quitclaim deed or other instrument conveying the title or interest to the owner of the property or interest if the defendant is listed as the owner of the property or interest in the county real property records;

1           (2) files for recording in the county property records  
2 a copy of the quitclaim deed or other instrument; and

3           (3) files a certified copy of the recorded quitclaim  
4 deed or other instrument with the court.

5           (c) The court shall reduce the amount of restitution that a  
6 defendant is ordered to pay under this article by an amount equal to  
7 the value of a payment made by a title company or insurer for a claim  
8 based on the conduct constituting the offense to the person to whom  
9 the court orders the defendant to pay restitution.

10           SECTION 4. Sections 51.901(c), (d), and (e), Government  
11 Code, are amended to read as follows:

12           (c) For purposes of this section, a document or instrument  
13 is presumed to be fraudulent if:

14           (1) the document is a purported judgment or other  
15 document purporting to memorialize or evidence an act, an order, a  
16 directive, or process of:

17                   (A) a purported court or a purported judicial  
18 entity not expressly created or established under the constitution  
19 or the laws of this state or of the United States; or

20                   (B) a purported judicial officer of a purported  
21 court or purported judicial entity described by Paragraph (A);

22           (2) the document or instrument purports to create a  
23 lien or assert a claim against real or personal property or an  
24 interest in real or personal property and all of the following are  
25 true:

26                   (A) the document or instrument is not a document  
27 or instrument provided for by the constitution or laws of this state

or of the United States;

(B) the document or instrument is not created by implied or express consent or agreement of the purported obligor, debtor, or grantor, or the owner of the real or personal property or an interest in the real or personal property, if required under the laws of this state, or by implied or express consent or agreement of an agent, fiduciary, or other representative of that person; and ~~[or]~~

(C) the document or instrument is not an equitable, constructive, or other lien imposed by a court with jurisdiction created or established under the constitution or laws of this state or of the United States; ~~[or]~~

(3) the document or instrument purports to create a lien or assert a claim against real or personal property or an interest in real or personal property and the document or instrument is filed by an inmate or on behalf of an inmate; or

(4) the document or instrument purports to create a lien or assert a claim against real or personal property or an interest in real or personal property and the document or instrument is referenced in a certified copy of the judgment for an offense under Chapter 31, 32, or 37, Penal Code.

(d) If a county clerk believes in good faith that a document filed with the county clerk to create a lien against or assert a claim to or interest in real or personal property is fraudulent, the clerk shall:

(1) request the assistance of the county or district attorney to determine whether the document is fraudulent before

1 filing or recording the document;

2 (2) request that the prospective filer provide to the  
3 county clerk additional documentation supporting the existence of  
4 the lien, claim, or interest, such as a contract or other document  
5 that contains the alleged ~~[debtor or]~~ obligor's, debtor's, or  
6 grantor's signature; and

7 (3) forward any additional documentation received to  
8 the county or district attorney.

9 (e) A presumption under Subsection (c)(3) may be rebutted by  
10 providing the filing officer in the filing office in which the  
11 document is filed or recorded the original or a copy of a sworn and  
12 notarized document signed by the obligor, debtor, grantor, or owner  
13 of the property or interest that is designated in the document or  
14 instrument that purports to create a lien or assert a claim against  
15 the property or interest [as collateral] stating that the person  
16 entered into an [a security] agreement with the inmate, including a  
17 security agreement for which the obligor, debtor, grantor, or owner  
18 of the property or interest [and] authorized the filing of the  
19 financing statement as provided by Section 9.509, Business &  
20 Commerce Code.

21 SECTION 5. The heading to Section 51.903, Government Code,  
22 is amended to read as follows:

25 SECTION 6. Sections 51.903(a), (b), (c), (e), and (g),  
26 Government Code, are amended to read as follows:

27 (a) A person who owns real or personal property or an

1 interest in real or personal property that is the subject of a  
2 document or instrument recorded in or filed for recording in the  
3 records of a county, or a person who is the purported ~~[debtor or]~~  
4 obligor, debtor, or grantor named in the document or instrument,  
5 ~~[or who owns real or personal property or an interest in real or~~  
6 ~~personal property and]~~ who has reason to believe that the document  
7 or instrument ~~[purporting to create a lien or a claim against the~~

(c) A motion under this section may be ruled on by a district judge having jurisdiction over real property matters in the county where the subject document or instrument was filed. The court's

finding may be made solely on a review of the document ~~[documentation]~~ or instrument attached to the motion and without hearing any testimonial evidence. The court's review may be made ex parte without delay or notice of any kind. An appellate court shall expedite review of a court's finding under this section.

(e) After reviewing the document ~~[documentation]~~ or instrument attached to a motion under this section, the district judge shall enter an appropriate finding of fact and conclusion of law, which must be filed and indexed in the same class of records in which the subject document ~~[documentation]~~ or instrument was originally filed. A copy of the finding of fact and conclusion of law shall be sent, by first class mail, to the movant and to the person who filed the document or instrument for recording ~~[fraudulent lien or claim]~~ at the last known address of each person within seven days of the date that the finding of fact and conclusion of law is issued by the judge.

SECTION 7. Chapter 31, Penal Code, is amended by adding  
Section 31.22 to read as follows:

Sec. 31.22. REAL PROPERTY THEFT. (a) In this section:

(1) "Nonpossessory interest" includes an interest  
that may be conveyed by a quitclaim deed or conditional transfer.

(2) "Owner" includes an owner's estate and known

1 successors in interest if the owner is deceased.

2 (3) "Transfer" has the meaning assigned by Section  
3 12.019, Property Code.

4 (b) A person commits an offense if the person:

5 (1) brings about or attempts to bring about a transfer  
6 or purported transfer of real property or title to real property or  
7 a nonpossessory interest in real property, to any transferee or  
8 intended transferee:

9 (A) without the effective consent of the owner of  
10 the real property or the nonpossessory interest in real property;  
11 and

12 (B) with the intent to deprive the owner of the  
13 real property or the nonpossessory interest in the real property;  
14 or

15 (2) sells or otherwise transfers or encumbers, or  
16 attempts to sell or otherwise transfer or encumber, real property  
17 or title to real property or a nonpossessory interest in real  
18 property to or with respect to a person in exchange for a benefit  
19 from any person:

20 (A) without the effective consent of the owner of  
21 the benefit; and

7 (1) a felony of the third degree if it is shown on the  
8 trial of the offense that the value of the benefit received is less  
9 than \$30,000;

11 trial of the offense that the value of the benefit received is  
12 \$30,000 or more but less than \$150,000; or

13 (3) a felony of the first degree if it is shown on the  
14 trial of the offense that the value of the benefit received is

16 (e) An offense described for purposes of punishment by  
17 Subsections (c) and (d) is increased to the next higher category of  
18 offense if it is shown on the trial of the offense that at the time

13               (2) "Document" and "effective consent" have the

15       (b) A person commits an offense if the person:

16               (1) intentionally or knowingly makes a materially  
17 false or misleading written statement to obtain real property; or

18               (2) with the intent to defraud or harm any person:

19                       (A) causes another person, without that person's  
20 effective consent, to sign or execute any document affecting real  
21 property or any person's interest in real property; or

22                       (B) causes a public servant, without the public  
23 servant's effective consent, to file or record any purported  
24 judgment or other document purporting to memorialize or evidence:

25                               (i) title to real property or any person's  
26 interest in real property; or

27                               (ii) a lien or claim against real property

or against any person's interest in real property.

(c) Except as provided by Subsection (d), an offense under this section is:

(1) a felony of the second degree if it is shown on the trial of the offense that the market value of the real property or the value of the interest in the real property is less than \$300,000; or

(2) a felony of the first degree if it is shown on the trial of the offense that the market value of the real property or the value of the interest in the real property is \$300,000 or more.

(d) An offense described for purposes of punishment by Subsection (b) is increased to the next higher category of offense if it is shown on the trial of the offense that at the time of the offense:

(1) the owner of the real property was:

(A) a person 65 years of age or older; or

(B) a nonprofit organization; or

(2) the real property was subject to a property tax exemption under Subchapter B, Chapter 11, Tax Code, as an individual's residence homestead as defined by Section 11.13(j), Tax Code.

(e) For purposes of Subsection (c), the market value of real property is the market value of that property for the tax year in which the offense was committed, as indicated on the appraisal roll for the appraisal district in which the property is located.

SECTION 9. Section 37.101(b), Penal Code, is amended to read as follows:

1           (b) An offense under Subsection (a)(1) is a felony of the  
2 third degree, unless it is shown on the trial of the offense that  
3 the person had previously been convicted under this section on two  
4 or more occasions, in which event the offense is a felony of the  
5 second degree. An offense under Subsection (a)(2) or (a)(3) is a  
6 state jail felony [~~Class A misdemeanor~~], unless the person commits  
7 the offense with the intent to defraud or harm another, in which  
8 event the offense is a [~~state jail~~] felony of the third degree.

9           SECTION 10. The changes in law made by this Act apply only  
10 to an offense committed on or after the effective date of this Act.  
11 An offense committed before the effective date of this Act is  
12 governed by the law in effect on the date the offense was committed,  
13 and the former law is continued in effect for that purpose. For  
14 purposes of this section, an offense was committed before the  
15 effective date of this Act if any element of the offense was  
16 committed before that date.

17           SECTION 11. The changes in law made by this Act in amending  
18 Article [12.01](#), Code of Criminal Procedure, do not apply to an  
19 offense if the prosecution of that offense becomes barred by  
20 limitation before the effective date of this Act. The prosecution  
21 of that offense remains barred as if this Act had not taken effect.

22           SECTION 12. This Act takes effect September 1, 2025.
