CONCURRENT RESOLUTION

1 WHEREAS, State law stipulates in Section 2165.256,
2 Government Code, that a person specified in a concurrent resolution
3 adopted by the legislature is eligible for burial in the State
4 Cemetery if the State Cemetery Committee finds that the person has
5 made a significant contribution to Texas history and, based on that
6 finding, approves the person's burial; and

7 WHEREAS, A graduate of The University of Texas School of Law,
8 Guy Herman was first elected as Travis County probate judge in 1985;
9 he has demonstrated exceptional wisdom and compassion in the
10 adjudication of sensitive matters relating to wills and estates,
11 guardianships, and mental health commitments, and as the county
12 population has doubled, he has overseen the growth of the court,
13 training and guiding associate judges and mentoring many law clerks
14 who have gone on to success in probate practices; and

15 WHEREAS, During his long tenure as presiding judge for the
16 Statutory Probate Judges of Texas, Judge Herman has rendered
17 exceptional service to the legal community and the legislature,
18 recommending beneficial changes to state laws and collaborating
19 effectively on legislative matters with the Real Estate, Probate,
20 and Trust Law sections of the State Bar of Texas; in 1993, he was
21 elected president of the Texas College of Probate Judges, and he has
22 served on numerous statewide and Supreme Court task forces over the
23 years; and

24 WHEREAS, From the very beginning of his career on the bench,

1 Judge Herman has worked to protect vulnerable populations; his
2 efforts have been crucial in preserving optimal autonomy and
3 independence for individuals with mental illness and in the
4 widespread adoption of warrantless detention rather than jailing
5 defendants prior to mental health treatment; moreover, he played a
6 key role in the development of the county's hospital district,
7 which provides primary, specialty, behavioral, and dental health
8 care to residents with insufficient resources; in recent years, he
9 has been instrumental in the creation of the Assisted Outpatient
10 Services approach to meet mental health needs of defendants; Travis
11 County Integral Care recognized his outstanding record of service
12 by naming its short-term residential psychiatric treatment
13 facility the Judge Guy Herman Center for Mental Health Crisis Care
14 in his honor; and

15 WHEREAS, In light of his noteworthy contributions to the Lone
16 Star State, it is fitting that the Honorable Guy Herman be allowed
17 to designate the State Cemetery as his final resting place; now,
18 therefore, be it

19 RESOLVED, That the 89th Legislature of the State of Texas
20 hereby authorize the burial of Guy Herman in the State Cemetery,
21 provided that his application for assignment of burial space is
22 approved by the State Cemetery Committee as required by law.
