- 9 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 10 SECTION 1. Article III, Texas Constitution, is amended by
- 11 adding Section 68 to read as follows:
- 12 Sec. 68. (a) The legislature shall establish the Dementia
- 13 Prevention and Research Institute of Texas to:
- 14 (1) award grants to institutions of learning, advanced
- 15 medical research facilities, public or private persons, and
- 16 <u>collaboratives in this state to provide money for:</u>
- 17 (A) research into the causes of, means of
- 18 prevention of, and treatment and rehabilitation for dementia,
- 19 Alzheimer's disease, Parkinson's disease, and related disorders;
- 20 (B) research, including translational research,
- 21 to develop therapies, protocols, medical pharmaceuticals, or
- 22 procedures for the substantial mitigation of the symptoms of
- 23 dementia, Alzheimer's disease, Parkinson's disease, and related
- 24 disorders;

1	(C) facilities, equipment, and other costs	
2	related to research on dementia, Alzheimer's disease, Parkinson's	
3	disease, and related disorders; and	
4	(D) prevention programs and strategies to	
5	mitigate the detrimental health impacts of dementia, Alzheimer's

7	(2) support institutions of learning and advanced	
8	medical research facilities and collaboratives in this state in all	
9	stages of:	
10	(A) discovering the causes of dementia,

12	(B) developing therapies, protocols, medical	
13	pharmaceuticals, or procedures for the substantial mitigation of	
14	the symptoms of dementia, Alzheimer's disease, Parkinson's disease,	
15	and related disorders from laboratory research to clinical trials;	
16	<u>and</u>	
17	(C) developing programs to address access to	
18	advanced treatment for dementia, Alzheimer's disease, Parkinson's	
19	disease, and related disorders; and	
20	(3) establish the appropriate standards and oversight	
21	bodies to ensure the proper use of funding authorized under this	
22	section, including facilities development.

- 20 (1) grants for research on dementia, Alzheimer's
- 21 disease, Parkinson's disease, and related disorders, research
- 22 facilities, and research opportunities in this state:
- 23 (A) for the prevention, treatment, and
- 24 rehabilitation of dementia, Alzheimer's disease, Parkinson's
- 25 disease, and related disorders and the mitigation of the incidence
- 26 of and detrimental health impacts from dementia, Alzheimer's
- 27 disease, Parkinson's disease, and related disorders; and

- 1 (B) to develop therapies, protocols, medical
- 2 pharmaceuticals, or procedures for the substantial mitigation of
- 3 the symptoms of dementia, Alzheimer's disease, Parkinson's disease,
- 4 and related disorders;
- 5 (2) the purchase, construction, or renovation,
- 6 <u>subject to the institute's approval, of facilities by or on behalf</u>
- 7 of a state agency or grant recipient; and
- 8 <u>(3) the institute's operation.</u>
- 9 <u>(f) Not including any unspent money appropriated to the</u>
- 10 Dementia Prevention and Research Institute of Texas carried forward
- 11 from the preceding state fiscal year, the legislature may
- 12 appropriate not more than \$300 million from the Dementia Prevention
- 13 and Research Fund to the institute for a state fiscal year.
- 14 (g) Before the Dementia Prevention and Research Institute
- 15 of Texas may award a grant authorized under this section, the grant
- 16 recipient must have available an unexpended amount of money equal
- 17 to one-half of the grant amount dedicated to the research specified
- 18 <u>in the grant proposal.</u>
- (h) The reasonable expenses of managing the assets of the
- 20 Dementia Prevention and Research Fund shall be paid from the fund.
- 21 SECTION 2. This proposed constitutional amendment shall be
- 22 submitted to the voters at an election to be held November 4, 2025.
- 23 The ballot shall be printed to permit voting for or against the
- 24 proposition: "The constitutional amendment providing for the
- 25 establishment of the Dementia Prevention and Research Institute of
- 26 Texas, establishing the Dementia Prevention and Research Fund to
