AN ACT

relating to the dates of certain elections, the procedures for canvassing the ballots for an election, and the counting of certain ballots voted by mail.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 41.007(b), Election Code, as amended by Section 1, H.B. No. 2496, Acts of the 78th Legislature, Regular Session, 2003, is amended to read as follows:

(b) The runoff primary election date is the second [~~first~~] Tuesday in April following the general primary election.

SECTION 2. Section 67.003, Election Code, as amended by Section 17, H.B. No. 1695, Acts of the 78th Legislature, Regular Session, 2003, is amended to read as follows:

Sec. 67.003. TIME FOR LOCAL CANVASS. Each local canvassing authority shall convene to conduct the local canvass at the time set by the canvassing authority's presiding officer on [+

~~[(A) the general election for state and county officers, or~~

~~[(B) an election of a political subdivision that is held jointly with an election of:~~

~~[(i) a county, or~~

10 (1) the ballot was cast from an address outside the

13 before the time the ballot is required to arrive under Subsection

25 SECTION 5. Sections 14, 16, and 42, H.B. No. 1549, Acts of
26 the 78th Legislature, Regular Session, 2003, are repealed.

27 SECTION 6. This Act takes effect September 1, 2003, if it

1 receives a vote of two-thirds of all the members elected to each
2 house, as provided by Section 39, Article III, Texas Constitution.
3 If this Act does not receive the vote necessary for effect on that
4 date, this Act takes effect November 1, 2003.
