18	of deliberations, the presiding officer shall announce publicly
19	individual members' decisions as to whether to recommend clemency.
20	Each member shall sign the member's name with the member's written
21	recommendation and reasons for the recommendation.
22	(c) The board shall adopt rules to implement the
23	requirements of this section.
