immediately, whichever time is later, if this Act receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for effect at that time, this Act takes effect on the 91st day after the last day of the legislative session.
