

AN ACT

relating to the construction, acquisition, financing, maintenance, management, operation, ownership, and control of transportation facilities and the progress, improvement, policing, and safety of transportation in the state; making appropriations.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

ARTICLE 1. TEXAS TURNPIKE AUTHORITY DIVISION OF
TEXAS DEPARTMENT OF TRANSPORTATION

SECTION 1.01. Section 361.136, Transportation Code, as amended by House Bill Nos. 3184 and 3588, Acts of the 78th Legislature, Regular Session, 2003, is reenacted to read as follows:

Sec. 361.136. SEVERANCE OF REAL PROPERTY. (a) If a turnpike project severs an owner's real property, the department shall pay:

(1) the value of the property acquired; and
(2) the damages to the remainder of the owner's property caused by the severance, including damages caused by the inaccessibility of one tract from the other.

(b) The department may negotiate for and purchase the severed real property or either part of the severed real property if the department and the owner agree on terms for the purchase. Instead of a single fixed payment for the real property, the department may agree to a payment to the owner in the form of:

1 (1) an intangible legal right to receive a percentage
2 of identified revenue attributable to the applicable segment of the
3 turnpike project; or

4 (2) an exclusive or nonexclusive right to use or
5 operate a segment or part of the turnpike project.

6 (c) A right to a payment under Subsection (b)(1) is subject
7 to any pledge of the revenue under the term of a trust agreement
8 securing bonds issued for the project.

9 SECTION 1.02. Section 361.137, Transportation Code, as
10 amended by House Bill Nos. 3184 and 3588, Acts of the 78th
11 Legislature, Regular Session, 2003, is reenacted to read as
12 follows:

13 Sec. 361.137. DECLARATION OF TAKING. (a) The department
14 may file a declaration of taking with the clerk of the court:

15 (1) in which the department files a condemnation
16 petition under Chapter 21, Property Code; or

17 (2) to which the case is assigned.

18 (b) The department may file the declaration of taking
19 concurrently with or subsequent to the petition but may not file the
20 declaration after the special commissioners have made an award in
21 the condemnation proceeding.

22 (c) The department may not file a declaration of taking
23 before the completion of:

24 (1) all environmental documentation, including a
25 final environmental impact statement or a record of decision, that
26 is required by federal or state law;

27 (2) all public hearings and meetings, including those

1 held in connection with the environmental process and under
2 Sections 201.604 and 203.021, that are required by federal or state
3 law; and

4 (3) all notifications required by Section 203.022.

5 (d) The declaration of taking must include:

6 (1) a specific reference to the legislative authority
7 for the condemnation;

8 (2) a description and plot plan of the real property to
9 be condemned, including the following information if applicable:

10 (A) the municipality in which the property is
11 located;

12 (B) the street address of the property; and

13 (C) the lot and block number of the property;

14 (3) a statement of the property interest to be
15 condemned;

16 (4) the name and address of each property owner that
17 the department can obtain after reasonable investigation and a
18 description of the owner's interest in the property; and

19 (5) a statement that immediate possession of all or
20 part of the property to be condemned is necessary for the timely
21 construction of a turnpike project.

22 (d-1) A deposit to the registry of the court of an amount
23 equal to the appraised value, as determined by the department, of
24 the property to be condemned must accompany the declaration of
25 taking.

26 (e) The date on which the declaration is filed is the date of
27 taking for the purpose of assessing damages to which a property

owner is entitled.

(f) After a declaration of taking is filed, the case shall proceed as any other case in eminent domain under Chapter 21, Property Code.

SECTION 1.03. Section 361.138(b), Transportation Code, as amended by House Bill Nos. 3184 and 3588, Acts of the 78th Legislature, Regular Session, 2003, is reenacted to read as follows:

(b) If the condemned property is a homestead or a portion of a homestead as defined by Section 41.002, Property Code, the department may not take possession sooner than the 91st day after the date of service under Subsection (a).

SECTION 1.04. Section 361.171, Transportation Code, as amended by House Bill Nos. 3184 and 3588, Acts of the 78th Legislature, Regular Session, 2003, is reenacted and amended to read as follows:

Sec. 361.171. TURNPIKE REVENUE BONDS. (a) The commission by order may authorize the issuance of turnpike revenue bonds to pay all or part of the cost of a turnpike project. Each project shall be financed and built by a separate bond issue. The proceeds of a bond issue may be used solely for the payment of the project for which the bonds were issued and may not be divided between or among two or more projects. Each project is a separate undertaking, the cost of which shall be determined separately.

(b) As determined in the order authorizing the issuance, the bonds of each issue shall:

(1) be dated;

1 (2) bear interest at the rate or rates provided by the
2 order and beginning on the dates provided by the order and as
3 authorized by law, or bear no interest;

4 (3) mature at the time or times provided by the order,
5 not exceeding 40 years from their date or dates; and

6 (4) be made redeemable before maturity, at the price
7 or prices and under the terms provided by the order.

8 (c) The commission may sell the bonds at public or private
9 sale in the manner and for the price it determines to be in the best
10 interest of the department.

11 (d) The proceeds of each bond issue shall be disbursed in
12 the manner and under the restrictions, if any, the commission
13 provides in the order authorizing the issuance of the bonds or in
14 the trust agreement securing the bonds.

15 (e) If the proceeds of a bond issue are less than the
16 turnpike project cost, additional bonds may be issued in the same
17 manner to pay the costs of a turnpike project. Unless otherwise
18 provided in the order authorizing the issuance of the bonds or in
19 the trust agreement securing the bonds, the additional bonds are on
20 a parity with and are payable, without preference or ~~of~~ priority,
21 from the same fund as the bonds first issued. In addition, the
22 commission may issue bonds for a turnpike project secured by a lien
23 on the revenue of the turnpike project subordinate to the lien on
24 the revenue securing other bonds issued for the turnpike project.

25 (f) If the proceeds of a bond issue exceed the cost of the
26 turnpike project for which the bonds were issued, the surplus shall
27 be segregated from the other money of the commission and used only

1 for the purposes specified in the order authorizing the issuance.

2 (g) In addition to other permitted uses, the proceeds of a
3 bond issue may be used to pay costs incurred before the issuance of
4 the bonds, including costs of environmental review, design,
5 planning, acquisition of property, relocation assistance,
6 construction, and operation.

7 (h) Bonds issued and delivered under this chapter and
8 interest coupons on the bonds are a security under Chapter 8,
9 Business & Commerce Code.

10 (i) Bonds issued under this chapter and income from the
11 bonds, including any profit made on the sale or transfer of the
12 bonds, are exempt from taxation in this state.

13 SECTION 1.05. Section 361.172, Transportation Code, as
14 amended by House Bill Nos. 3184 and 3588, Acts of the 78th
15 Legislature, Regular Session, 2003, is reenacted to read as
16 follows:

17 Sec. 361.172. APPLICABILITY OF OTHER LAW; CONFLICTS. All
18 laws affecting the issuance of bonds by governmental entities,
19 including Chapters 1201, 1202, 1204, 1207, and 1371, Government
20 Code, apply to bonds issued under this chapter. To the extent of a
21 conflict between those laws and this chapter, the provisions of
22 this chapter prevail.

23 SECTION 1.06. Section 361.173(a), Transportation Code, as
24 amended by House Bill Nos. 3184 and 3588, Acts of the 78th
25 Legislature, Regular Session, 2003, is reenacted and amended to
26 read as follows:

27 (a) The principal of, interest on, and any redemption

premium on bonds issued by the commission under this chapter are payable solely from:

(1) the revenue of the turnpike project for which the bonds are ~~[were]~~ issued, including tolls pledged to pay the bonds; ~~[and]~~

(2) the proceeds of bonds issued for the turnpike project;

(3) the amounts deposited in a debt service reserve fund as required by the trust agreement securing bonds issued for the turnpike project; and

(4) amounts received under a credit agreement relating to the turnpike project for which the bonds are issued.

SECTION 1.07. Section 361.174, Transportation Code, as amended by House Bill Nos. 3184 and 3588, Acts of the 78th Legislature, Regular Session, 2003, is reenacted and amended to read as follows:

Sec. 361.174. SOURCES OF PAYMENT OF AND SECURITY FOR TURNPIKE PROJECT BONDS. Notwithstanding any other provisions of this chapter, turnpike project bonds issued by the commission may:

(1) be payable from and secured by:

(A) payments made under an agreement with a local governmental entity as provided by Subchapter A, Chapter 362;

(B) the proceeds of bonds issued for the turnpike project; or

(C) amounts deposited in a debt service reserve fund as required by the trust agreement securing bonds issued for the turnpike project; ~~[7]~~ and

1 (2) ~~[may]~~ state on their faces any pledge of revenue or
2 taxes and any security for the bonds under the agreement.

3 SECTION 1.08. Section 361.177, Transportation Code, as
4 amended by House Bill Nos. 3184 and 3588, Acts of the 78th
5 Legislature, Regular Session, 2003, is reenacted to read as
6 follows:

7 Sec. 361.177. PROVISIONS PROTECTING AND ENFORCING RIGHTS
8 AND REMEDIES OF BONDHOLDERS. A trust agreement or order providing
9 for the issuance of bonds may contain provisions to protect and
10 enforce the rights and remedies of the bondholders, including:

11 (1) covenants establishing the commission's duties
12 relating to:

13 (A) the acquisition of property;

14 (B) the construction, improvement, expansion,
15 maintenance, repair, operation, and insurance of the turnpike
16 project in connection with which the bonds were authorized; and

17 (C) the custody, safeguarding, and application
18 of money;

19 (2) covenants prescribing events that constitute
20 default;

21 (3) covenants prescribing terms on which any or all of
22 the bonds become or may be declared due before maturity;

23 (4) covenants relating to the rights, powers,
24 liabilities, or duties that arise on the breach of a duty of the
25 commission; and

26 (5) provisions for the employment of consulting
27 engineers in connection with the construction or operation of the

1 turnpike project.

2 SECTION 1.09. Section 361.178, Transportation Code, as
3 amended by House Bill Nos. 3184 and 3588, Acts of the 78th
4 Legislature, Regular Session, 2003, is reenacted to read as
5 follows:

6 Sec. 361.178. FURNISHING OF INDEMNIFYING BONDS OR PLEDGE OF
7 SECURITIES. A bank or trust company incorporated under the laws of
8 this state that acts as depository of the proceeds of bonds or of
9 revenue may furnish indemnifying bonds or pledge securities that
10 the department requires.

11 SECTION 1.10. Section 361.179(a), Transportation Code, as
12 amended by House Bill Nos. 3184 and 3588, Acts of the 78th
13 Legislature, Regular Session, 2003, is reenacted and amended to
14 read as follows:

15 (a) The department may:

16 (1) impose tolls for the use of each turnpike project
17 and the different segments or parts [~~or sections~~] of each turnpike
18 project; and

19 (2) notwithstanding anything in Chapter 202 to the
20 contrary, contract with a person for the use of part of a turnpike
21 project or lease part of a turnpike project for a gas station,
22 garage, store, hotel, restaurant, railroad tracks, utilities, and
23 telecommunications facilities and equipment and set the terms for
24 the use or lease.

25 SECTION 1.11. Section 361.185(a), Transportation Code, as
26 amended by House Bill Nos. 3184 and 3588, Acts of the 78th
27 Legislature, Regular Session, 2003, is reenacted to read as

1 follows:

2 (a) All money received under this chapter, whether as
3 proceeds from the sale of bonds or as revenue, is a trust fund to be
4 held and applied as provided by this chapter. Notwithstanding any
5 other law, including Section 9, Chapter 1123, Acts of the 75th
6 Legislature, Regular Session, 1997, and without the prior approval
7 of the comptroller, funds held under this chapter shall be held in
8 trust by a banking institution chosen by the department or, at the
9 discretion of the department, in trust in the state treasury
10 outside the general revenue fund.

11 SECTION 1.12. Section 361.189, Transportation Code, as
12 amended by House Bill Nos. 3184 and 3588, Acts of the 78th
13 Legislature, Regular Session, 2003, is reenacted to read as
14 follows:

15 Sec. 361.189. USE OF SURPLUS REVENUE. The commission by
16 order may authorize the use of surplus revenue of a turnpike project
17 to pay the costs of another turnpike project within the region. The
18 commission may in the order prescribe terms for the use of the
19 revenue, including the pledge of the revenue, but may not take an
20 action under this section that violates, impairs, or is
21 inconsistent with a bond order, trust agreement, or indenture
22 governing the use of the surplus revenue.

23 SECTION 1.13. Section 361.302, Transportation Code, as
24 amended by House Bill Nos. 3184 and 3588, Acts of the 78th
25 Legislature, Regular Session, 2003, is reenacted and amended to
26 read as follows:

27 Sec. 361.302. COMPREHENSIVE DEVELOPMENT AGREEMENTS.

1 (a) Subject to Section 361.3021, the department may enter into a
2 comprehensive development agreement with a private entity to
3 construct, maintain, repair, operate, extend, or expand a turnpike
4 project.

5 (b) In this subchapter, "comprehensive development
6 agreement" means an agreement [~~with a private entity~~] that, at a
7 minimum, provides for the design and construction of a turnpike
8 project and may also provide for the financing, acquisition,
9 maintenance, or operation of a turnpike project.

10 (c) The department may negotiate provisions relating to
11 professional and consulting services provided in connection with a
12 comprehensive development agreement.

13 (d) Money disbursed by the department under a comprehensive
14 development agreement is not included in the amount:

15 (1) required to be spent in a state fiscal biennium for
16 engineering and design contracts under Section 223.041; or

17 (2) appropriated in Strategy A.1.1.
18 Plan/Design/Manage of the General Appropriations Act for that
19 biennium for the purpose of making the computation under Section
20 223.041.

21 (e) The authority to enter into comprehensive development
22 agreements provided by this section expires on August 31, 2011.

23 SECTION 1.14. Section 361.3021, Transportation Code, as
24 added by House Bill Nos. 3184 and 3588, Acts of the 78th
25 Legislature, Regular Session, 2003, is reenacted to read as
26 follows:

27 Sec. 361.3021. LIMITATION ON DEPARTMENT FINANCIAL

1 PARTICIPATION. The amount of money disbursed by the department
2 from the state highway fund and the Texas mobility fund during a
3 federal fiscal year to pay the costs under comprehensive
4 development agreements may not exceed 40 percent of the obligation
5 authority under the federal-aid highway program that is distributed
6 to this state for the fiscal year.

7 SECTION 1.15. Section 361.303(a), Transportation Code, as
8 amended by House Bill Nos. 3184 and 3588, Acts of the 78th
9 Legislature, Regular Session, 2003, is reenacted to read as
10 follows:

11 (a) A turnpike project that is the subject of a
12 comprehensive development agreement with a private entity,
13 including the facilities acquired or constructed on the project, is
14 public property and belongs to the department.

15 SECTION 1.16. Section 361.305, Transportation Code, as
16 amended by House Bill Nos. 3184 and 3588, Acts of the 78th
17 Legislature, Regular Session, 2003, is reenacted and amended to
18 read as follows:

19 Sec. 361.305. TERMS OF PRIVATE PARTICIPATION. (a) The
20 department shall negotiate the terms of private participation in a
21 turnpike project, including:

22 (1) methods to determine the applicable cost, profit,
23 and project distribution between the private equity investors and
24 the department;

25 (2) reasonable methods to determine and classify toll
26 rates;

27 (3) acceptable safety and policing standards; and

1 (4) other applicable professional, consulting,
2 construction, operation, and maintenance standards, expenses, and
3 costs.

4 (b) A comprehensive development agreement entered into
5 under Section 361.302 must include a provision authorizing the
6 department to purchase, under terms and conditions agreed to by the
7 parties, the interest of a private equity investor in a turnpike
8 agreement.

9 (c) The department may [~~only~~] enter into a comprehensive
10 development agreement under Section 361.302 with a private equity
11 investor only if the project is identified in the department's
12 unified transportation program or is located on a transportation
13 corridor identified in the statewide transportation plan.

14 SECTION 1.17. Section 361.306, Transportation Code, as
15 amended by House Bill Nos. 3184 and 3588, Acts of the 78th
16 Legislature, Regular Session, 2003, is reenacted to read as
17 follows:

18 Sec. 361.306. RULES, PROCEDURES, AND GUIDELINES GOVERNING
19 SELECTION AND NEGOTIATING PROCESS. (a) The commission shall adopt
20 rules, procedures, and guidelines governing selection and
21 negotiations to promote fairness, obtain private participants in
22 turnpike projects, and promote confidence among those
23 participants. The rules must contain criteria relating to the
24 qualifications of the participants and the award of the contracts.

25 (b) The department shall have up-to-date procedures for
26 participation in negotiations on turnpike projects.

27 (c) The department has exclusive judgment to determine the

1 terms of an agreement.

2 (d) The department shall include the attorney general or the
3 attorney general's designated representative in a negotiation with
4 a private participant.

5 SECTION 1.18. Section 361.307, Transportation Code, as
6 amended by House Bill Nos. 3184 and 3588, Acts of the 78th
7 Legislature, Regular Session, 2003, is reenacted to read as
8 follows:

9 Sec. 361.307. AGREEMENTS WITH PRIVATE ENTITIES AND OTHER
10 GOVERNMENTAL AGENCIES. (a) The department and a private entity
11 jointly may enter into an agreement with another governmental
12 agency or entity, including a federal agency, an agency of this or
13 another state, including the United Mexican States or a state of the
14 United Mexican States, or a political subdivision, to independently
15 or jointly provide services, to study the feasibility of a turnpike
16 project, or to finance, construct, operate, and maintain a turnpike
17 project.

18 (b) The department may not enter into an agreement with the
19 United Mexican States or a state of the United Mexican States
20 without the approval of the governor.

21 SECTION 1.19. Section 361.281, Transportation Code, as
22 amended by House Bill Nos. 3184 and 3588, Acts of the 78th
23 Legislature, Regular Session, 2003, is amended to read as follows:

24 Sec. 361.281. APPLICABILITY OF SUBCHAPTER. This subchapter
25 applies only to:

26 (1) a county with a population of more than 1.5
27 million;

1 (2) a local government corporation serving a county
2 with a population of more than 1.5 million;

3 (3) an adjacent county in a joint turnpike authority
4 with a county with a population of more than 1.5 million;

5 (4) a municipality with a population of more than
6 170,000 that is adjacent to the United Mexican States;

7 (5) a regional tollway authority created under Chapter
8 366; or

9 (6) a regional mobility authority organized ~~created~~
10 under Chapter 370 or Section 361.003, as that section existed
11 before June 22, 2003.

12 ARTICLE 2. STATE TRAFFIC FINE AND DRIVER RESPONSIBILITY

13 PROGRAM SURCHARGES

14 SECTION 2.01. The heading to Section 542.4031,
15 Transportation Code, as added by House Bill No. 3588, Acts of the
16 78th Legislature, Regular Session, 2003, is amended to read as
17 follows:

18 Sec. 542.4031. STATE TRAFFIC FINE ~~[ADDITIONAL COURT COST]~~.

19 SECTION 2.02. Sections 542.4031(a)-(d) and (h),
20 Transportation Code, as added by House Bill No. 3588, Acts of the
21 78th Legislature, Regular Session, 2003, are amended to read as
22 follows:

23 (a) In addition to the fine prescribed by Section 542.401 or
24 another section of this subtitle, as applicable ~~[other costs,~~
25 ~~including a cost under Section 542.403]~~, a person who enters a plea
26 of guilty or nolo contendere to or is convicted of an offense under
27 this subtitle shall pay \$30 as a state traffic fine ~~[court cost]~~.

1 The person shall pay the state traffic fine when the person enters
2 the person's plea of guilty or nolo contendere, or on the date of
3 conviction, whichever is earlier. The state traffic fine shall be
4 paid regardless of whether:

5 (1) a sentence is imposed on the person;

6 (2) the court defers final disposition of the person's
7 case; or

8 (3) the person is placed on community supervision,
9 including deferred adjudication community supervision.

10 (b) An officer collecting a state traffic fine ~~[cost due]~~
11 under this section in a case in municipal court shall keep separate
12 records of the money collected and shall deposit the money in the
13 municipal treasury.

14 (c) An officer collecting a state traffic fine ~~[cost due]~~
15 under this section in a justice, county, or district court shall
16 keep separate records of the money collected and shall deposit the
17 money in the county treasury.

18 (d) Each calendar quarter, an officer collecting a state
19 traffic fine ~~[cost due]~~ under this section shall submit a report to
20 the comptroller. The report must comply with Articles 103.005(c)
21 and (d), Code of Criminal Procedure. ~~[If no money due as a cost~~
22 ~~under this section is collected in any quarter, the report required~~
23 ~~for that quarter shall be filed in the regular manner, and the~~
24 ~~report shall state that no money due under this section was~~
25 ~~collected.]~~

26 (h) Notwithstanding Subsection (g)(1), in any state fiscal
27 year the comptroller shall deposit 67 percent of the money ~~[court~~

costs] received under Subsection (e)(2) [~~that subsection~~] to the credit of the general revenue fund only until the total amount of the money [~~court costs~~] deposited to the credit of the general revenue fund under Subsection (g)(1) [~~that subsection~~] and [~~the surcharges deposited to the credit of that fund under~~] Section 780.002(b), Health and Safety Code, equals \$250 million for that year. If in any state fiscal year the amount received by the comptroller under those laws for deposit to the credit of the general revenue fund exceeds \$250 million, the comptroller shall deposit the additional amount [~~received under Subsection (g)~~] to the credit of the Texas mobility fund.

SECTION 2.03. (a) Sections 708.051 and 708.101, Transportation Code, as added by House Bill No. 3588, Acts of the 78th Legislature, Regular Session, 2003, are amended to read as follows:

Sec. 708.051. NONAPPLICABILITY. This subchapter does not apply to:

(1) an offense committed [~~a conviction that became final~~] before September 1, 2003; or

(2) an offense covered by Subchapter C.

Sec. 708.101. NONAPPLICABILITY. This subchapter does not apply to an offense committed [~~a conviction that became final~~] before September 1, 2003.

(b) In connection with a conviction for an offense committed before September 1, 2003, that became final on or after that date, the Department of Public Safety:

(1) shall refund any surcharge collected under Chapter

1 708, Transportation Code, as added by H.B. No. 3588, Acts of the
2 78th Legislature, Regular Session, 2003; and

3 (2) may not assign points to a person's driver's
4 license under that chapter.

5 SECTION 2.04. Section 708.155, Transportation Code, as
6 added by H.B. No. 3588, Acts of the 78th Legislature, Regular
7 Session, 2003, is amended to read as follows:

8 Sec. 708.155. CONTRACTS FOR COLLECTION OF SURCHARGES. The
9 department may enter into a contract with a private attorney or a
10 public or private vendor for the provision of services for the
11 collection of surcharges receivable and related costs under this
12 chapter. The total amount of compensation may not exceed 30 percent
13 of the amount of the surcharges and related costs collected [~~set in~~
14 ~~Article 103.0031, Code of Criminal Procedure~~].

15 SECTION 2.05. Section 780.002(c), Health and Safety Code,
16 as added by House Bill No. 3588, Acts of the 78th Legislature,
17 Regular Session, 2003, is amended to read as follows:

18 (c) Notwithstanding Subsection (b), in any state fiscal
19 year the comptroller shall deposit 49.5 percent of the surcharges
20 collected under Chapter 708, Transportation Code, to the credit of
21 the general revenue fund only until the total amount of the
22 surcharges deposited to the credit of the general revenue fund
23 under Subsection (b), and the state traffic fines [~~court costs~~]
24 deposited to the credit of that fund under Section 542.4031(g)(1),
25 Transportation Code, equals \$250 million for that year. If in any
26 state fiscal year the amount received by the comptroller under
27 those laws for deposit to the credit of the general revenue fund

1 exceeds \$250 million, the comptroller shall deposit [~~49.5 percent~~
2 ~~of~~] the additional amount [~~received under Subsection (a) to the~~
3 ~~account established under this chapter and 49.5 percent of the~~
4 ~~additional amount~~] to the credit of the Texas mobility fund.

5 ARTICLE 3. FINANCIAL PROVISIONS

6 SECTION 3.01. Section 20.02, House Bill No. 3588, Acts of
7 the 78th Legislature, Regular Session, 2003, is amended to read as
8 follows:

9 Sec. 20.02. (a) [~~The comptroller shall establish the Texas~~
10 ~~mobility fund debt service account as a dedicated account within~~
11 ~~the general revenue fund.~~

12 [~~(b)~~] Notwithstanding Sections 780.002(b) and (c)
13 [~~780.002(a) and (b)~~], Health and Safety Code, as added by this Act,
14 of the money allocated to the undedicated portion of the general
15 revenue fund by Section 780.002(b) [~~780.002(a)~~], Health and Safety
16 Code, as added by this Act, other than money that may only be

(a) Notwithstanding other provisions of this Act, based upon the passage of federal legislation that provides federal funds for the purpose of state fiscal relief, such funds are appropriated~~[, after the implementation of Section 11.15, Contingency Appropriation Reduction and Contingency Appropriation,~~ to the Comptroller of Public Accounts in the fiscal year in which the funds are received for the purpose of transferring funds to state agencies for state fiscal relief, as directed by the Governor and Legislative Budget Board acting under Chapter 317, Government Code, and in accordance with ~~[provided by subsection (b) of]~~ this section.

(c) In addition to the priorities established by Subsection (b) of this section, such funds shall also be used for the state child health plan, Goal C of the appropriations to the Health and Human Services Commission (insure children), to provide necessary and appropriate short-term evaluative or crisis intervention mental health services and services for the treatment of serious mental illness.

1 (d) In addition to the priorities otherwise established by
2 this section, it is also a priority of the Legislature that the plan
3 provide funding to permit a Medicaid recipient, including an adult
4 recipient, to select a licensed psychologist, a licensed marriage
5 and family therapist, as defined by Section 502.002, Occupations
6 Code, a licensed professional counselor, as defined by Section
7 503.002, Occupations Code, or a licensed master social worker, as
8 defined by Section 505.002, Occupations Code, to perform
9 professional counseling services or other health care services or
10 procedures covered under the Medicaid program if the selected
11 person is authorized by law to perform the counseling or other
12 services or procedures.

1 (e) A request to take a driving safety course or motorcycle
2 operator training course made at or before the time and at the place
3 at which a defendant is required to appear in court is an appearance
4 in compliance with the defendant's promise to appear.

5 (1) When a defendant complies with Subsection (c), the court
6 shall:

7 (1) remove the judgment and dismiss the charge;

8 (2) report the fact that the defendant successfully
9 completed a driving safety course or a motorcycle operator training
10 course and the date of completion to the Texas Department of Public
11 Safety for inclusion in the person's driving record; and

12 (3) state in that report whether the course was taken
13 under this article to provide information necessary to determine
14 eligibility to take a subsequent course under Subsection (b).

15 (m) The court may dismiss only one charge for each
16 completion of a course.

17 (n) A charge that is dismissed under this article may not be
18 part of a person's driving record or used for any purpose.

19 (o) An insurer delivering or issuing for delivery a motor
20 vehicle insurance policy in this state may not cancel or increase
21 the premium charged an insured under the policy because the insured
22 completed a driving safety course or a motorcycle operator training
23 course, or had a charge dismissed under this article.

24 (p) The court shall advise a defendant charged with a
25 misdemeanor under Section 472.022, Transportation Code, Subtitle
26 C, Title 7, Transportation Code, or Section 729.001(a)(3),
27 Transportation Code, committed while operating a motor vehicle of

1 the defendant's right under this article to successfully complete a
2 driving safety course or, if the offense was committed while
3 operating a motorcycle, a motorcycle operator training course. The
4 right to complete a course does not apply to a defendant charged
5 with:

6 (1) a violation of Section 545.066, 550.022, or
7 550.023, Transportation Code;

8 (2) a serious traffic violation; or

9 (3) an offense to which Section 542.404 or 729.004(b),
10 Transportation Code, applies.

11 (q) A notice to appear issued for an offense to which this
12 article applies must inform a defendant charged with an offense
13 under Section 472.022, Transportation Code, an offense under
14 Subtitle C, Title 7, Transportation Code, or an offense under
15 Section 729.001(a)(3), Transportation Code, committed while
16 operating a motor vehicle of the defendant's right to complete a
17 driving safety course or, if the offense was committed while
18 operating a motorcycle, of the defendant's right to complete a
19 motorcycle operator training course. The notice required by this
20 subsection must read substantially as follows:

21 "You may be able to require that this charge be dismissed by
22 successfully completing a driving safety course or a motorcycle
23 operator training course. You will lose that right if, on or before
24 your appearance date, you do not provide the court with notice of
25 your request to take the course."

26 (r) If the notice required by Subsection (q) is not provided
27 to the defendant charged with the offense, the defendant may

1 continue to exercise the defendant's right to take a driving safety
2 course or a motorcycle operator training course until the notice
3 required by Subsection (q) is provided to the defendant or there is
4 a final disposition of the case.

5 (s) This article does not apply to an offense committed by a
6 person who holds a commercial driver's license.

7 (t) An order of deferral under Subsection (c) terminates any
8 liability under a bail bond or appearance bond given for the charge.

9 SECTION 4.03. Article 45.051(c-1), Code of Criminal

 2 and (E) and Subsection (a)(3) by department district. The report
 3 must break down information under Subsection (a)(2) by department
 4 district and type of project.

5 (c) The report may be submitted in an electronic format.

6 SECTION 5.03. Section 227.014(a), Transportation Code, as
 7 added by House Bill No. 3588, Acts of the 78th Legislature, Regular
 8 Session, 2003, is amended to read as follows:

9 (a) If the commission determines that the mobility needs of
 10 this state would be most efficiently and economically met by
 11 jointly operating two or more facilities as one operational and
