

R E S O L U T I O N

1           WHEREAS, On August 28, 2003, the Hope of South Texas  
2 organization hosted its 17th Annual Roast and Fundraiser and paid  
3 special tribute to Janey Lack of Victoria, a notable community  
4 leader who has given generously of herself to make the Lone Star  
5 State a better place in which to live, work, and raise a family; and

6           WHEREAS, An alumna of the University of Michigan, Mrs. Lack  
7 completed, with distinction, the Harvard-Radcliffe Program in  
8 Business Administration in 1964, and a year later she earned her MBA  
9 at the Harvard Graduate School of Business and joined the staff of  
10 McKinsey & Co. as a management consultant; she has served as vice  
11 president of marketing and advertising for Lack's Stores since  
12 1992; and

13           WHEREAS, Mrs. Lack has devoted much of her life to supporting  
14 civic and charitable endeavors, including the HEAR Foundation, the  
15 Hope of South Texas, a nonprofit group that works to prevent sexual  
16 violence in the six-county area near Victoria, and the Citizens  
17 Medical Center, which has recently appointed her to its board of  
18 directors; she is a strong supporter of higher education programs,  
19 serving since 1988 as a member of the advisory council for The  
20 University of Texas at Austin, College of Education Foundation, and  
21 since 2000 as a member of the Dean's Advisory Council at the  
22 University of Michigan, LSA College; in addition, she is a  
23 recipient of the South Texas Woman Award and has been recognized by  
24 the Texas Mid-Coast Reading Council for her work as a literacy

2 WHEREAS, Her belief in the importance of helping others has  
3 also led her to seek public office; she is a former member of the  
4 Victoria City Council, having served her constituents with  
5 integrity for seven years; and

6 WHEREAS, Over the course of her illustrious career as a  
7 businesswoman, elected official, and community leader, Janey Lack  
8 has distinguished herself as an individual of commitment, courage,  
9 and compassion, and she is indeed deserving of special recognition;  
10 now, therefore, be it

11 RESOLVED, That the House of Representatives of the 78th Texas  
12 Legislature, 3rd Called Session, hereby commend Janey Lack of  
13 Victoria for her exceptional contributions to her community and  
14 state and extend to her best wishes for much success and happiness  
15 in all her future endeavors; and, be it further

16 RESOLVED, That an official copy of this resolution be  
17 prepared for Mrs. Lack as an expression of high regard by the Texas  
18 House of Representatives.
