1           WHEREAS, A 60th wedding anniversary is truly cause for a  
2 celebration, and on October 24, 2003, Bill O. Simmons, Sr., and  
3 Bobbie Simmons of Llano County are marking this momentous milestone  
4 in their marriage; and

5           WHEREAS, Mr. Simmons and the former Bobbie Peters were  
6 married on October 24, 1943, at St. Joseph's Catholic Church in Ada,  
7 Oklahoma, where he was stationed in the Army Air Corps; throughout  
8 their marriage, the couple have enjoyed a fulfilling relationship,  
9 and they have been blessed with a fine family that includes their  
10 sons, Bill O. Simmons, Jr., and Paul D. Simmons, a granddaughter,  
11 Ellen Hargrove, and a great-granddaughter, Claire Elizabeth; and

12           WHEREAS, Deeply dedicated to her family and her faith, Mrs.  
13 Simmons continues to provide a welcoming home for her loved ones;  
14 she serves her community through her involvement with the Llano  
15 County Republican Women's Club, which she has served through  
16 various committees and as a current board member, and she received  
17 the Contribution to Women Award at the 2002 Texas Federation of  
18 Republican Women state convention; in addition, Mrs. Simmons has  
19 served as president of the altar society at St. Ann Catholic Church;

22 during World War II as a member of the 9th Air Force, and he joined  
23 the reserves in 1946; recalled to active duty, he was stationed at

2 Public Safety in 1947, and the couple lived in Austin, Gainesville,  
3 and Corsicana before moving to Midland in 1956, where Mr. Simmons  
4 embarked on a new chapter in his life and began a career in the oil  
5 industry; and

6           WHEREAS, The co-owner of Quality Logging, Inc., in Midland,  
7 he moved with his wife to Llano County 13 years ago and has served  
8 his fellow citizens as county commissioner, chair of the Llano  
9 County Republican Party, and church council president of St.  
10 Charles Boromero Catholic Church in Kingsland, where the couple are  
11 valued congregants; moreover, Mr. Simmons is serving on the  
12 Telecommunication Infrastructure Fund Board under an appointment  
13 by Governor Rick Perry; and
