WHEREAS, The recipient of multiple scholarships, Mr. Hill 16 graduated from Martin High School in Arlington and maintained a 17 perfect 4.0 GPR throughout his career at Texas A&M; he served as 18 president of the College of Agriculture and Life Sciences Student 19 Council and represented his college in the Student Senate; he also 20 21 served as executive vice president of the Student Government and 22 became the first Texas A&M student to cochair a national search committee for a top-level university official when he participated 23 24 in the search for a vice president of student affairs; and
