RESOLUTION

BE IT RESOLVED by the Senate of the State of Texas, 78th 1 2 Legislature, 3rd Called Session, 2003, That Senate Rule 12.03 be suspended in part as provided by Senate Rule 12.08 to enable the 3 conference committee appointed to resolve the differences on House 4 Bill 7, relating to the reorganization of, efficiency in, and other 5 reform measures applying to governmental entities and certain 6 7 regulatory practices, to consider and take action on the following 8 matters:

Senate Rules 12.03(3) and (4) are suspended to permit 9 (1)10 the committee to add a new article to the bill to read as follows: ARTICLE ____. FINANCIAL DISCLOSURE FOR BOARDS OF TRUSTEES OF 11 CERTAIN SCHOOL DISTRICTS 12

SECTION ___.01. Section 11.064, Education Code, as added by 13 Chapter 249, Acts of the 78th Legislature, Regular Session, 2003, 14 amended by amending Subsections (a) and (c) and adding 15 is Subsections (a-1), (a-2), (a-3), and (a-4) to read as follows: 16

9	financial activity occurring before January 1 of the year following

12	the board of trustees of an independent school district to file the
13	financial statement required of state officers under Subchapter B,
14	Chapter 572, Government Code, in the same manner as the members of a
15	board of trustees that have adopted a resolution under Subsection
16	(a) if the commissioner determines that:
17	(1) a board member has failed to comply with filing and
18	recusal requirements applicable to the member under Chapter 171,

trustees subject to an order issued under Subsection (a-3) is not 1 2 required to include, in a financial disclosure statement subject to this section, financial activity occurring before January 1 of the 3 4 year following the year in which the order is issued. The commissioner may renew the requirement if the commissioner 5 6 determines that a condition described by Subsection (c) continues to exi<u>st.</u> 7 8 (c) A trustee serving in a school district that has adopted

9 <u>a resolution under Subsection (a) or that is subject to an order</u> 10 <u>issued under Subsection (a-3)</u> [subject to this section] commits an 11 offense if the trustee fails to file the statement required by <u>the</u> 12 <u>resolution or order</u> [this section]. An offense under this section 13 is a Class B misdemeanor.

14 SECTION __.02. Section 6.08, Chapter 249, Acts of the 78th
15 Legislature, Regular Session, 2003, is repealed.

SECTION __.03. This article takes effect immediately if this Act receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Onstitution. If this Act does not receive the vote necessary for immediate effect, this article takes effect on the 91st day after the last day of the legislative session.

Explanation: It is necessary to add this article to add changes regarding ethics issues for members of the boards of trustees of certain independent school districts.

6 SECTION __.02. The changes in law made by this article apply 7 only to a vacancy application existing or made on or after the 8 effective date of this Act.

9 Explanation: It is necessary to add this article to modify 10 the time frame to determine when a person may apply for 11 good-faith-claimant status for the sale or lease of vacant public 12 land.
