## RESOLUTION

1 WHEREAS, The retirement of Dr. Carolyn Bukhair as 2 superintendent of the Richardson Independent School District (ISD) 3 on June 30, 2004, concludes a lengthy and impressive career 4 dedicated to students of the Lone Star State; and

5 WHEREAS, Dr. Bukhair holds a bachelor's degree from Lamar 6 University, a master's degree from Southern Methodist University, 7 and a doctorate in education from the University of North Texas; and

WHEREAS, Over the course of 38 outstanding years in the field 8 of education--29 of those years with the Richardson ISD--Dr. 9 Bukhair served as a fourth-grade classroom teacher and secondary 10 11 reading consultant before becoming director of elementary 12 education, principal, assistant to the superintendent, area assistant superintendent, assistant superintendent for 13 the 14 division of instruction, and associate superintendent for instructional support services; and 15

WHEREAS, Since accepting the top leadership post of the 16 Richardson ISD in 1996, Dr. Bukhair has overseen the addition of six 17 18 new schools, the renovation of existing buildings, and the opening of the Newcomer Intake Center; under her guidance, the district has 19 also strengthened academic programs, joined the Texas Scholars 20 21 Program, increased its budget by 65 percent, enhanced technology on 22 all campuses, and established a partnership with the City of 23 Richardson to build a fiber optic network connecting district 24 facilities; and

6 WHEREAS, When she retires, this highly regarded individual 7 anticipates spending more time with her children and grandchildren, 8 attending ball games, and becoming more active in church and civic 9 endeavors; and

10 WHEREAS, Throughout her career, Dr. Bukhair has set high 11 standards to which all educators and administrators may aspire, and 12 she is indeed worthy of special recognition at this time; now, 13 therefore, be it

14 RESOLVED, That the House of Representatives of the 78th Texas 15 Legislature, 4th Called Session, hereby commend Dr. Carolyn Bukhair 16 on the occasion of her retirement as superintendent of the 17 Richardson Independent School District and extend to her sincere 18 best wishes for happiness and fulfillment in the years ahead; and, 19 be it further
