1 WHEREAS, Harlan "Jim" Berger has completed his term as
2 president of the Independent Insurance Agents of Texas, and his
3 exemplary service in this role has earned him additional respect
4 and admiration from his colleagues in the insurance industry; and

5 WHEREAS, A Texas native, Mr. Berger grew up in Schulenburg
6 and attended Texas A&M University, where he was a member of the
7 Corps of Cadets; after graduating as a distinguished military
8 student in 1968, he began a three-and-a-half-year stint with the
9 U.S. Army, achieving the rank of captain; and

15 Alliance and played a key role in the formation of that
16 organization; and

17 WHEREAS, This esteemed gentleman has served on the insurance
18 advisory boards of Chubb, CNA, Trinity Insurance Services, Inc.,
19 and Texas Mutual Insurance Company, among others, and his
20 noteworthy efforts were recognized when he was selected as the
21 first recipient of the Zurich Insurance Companies' Pathfinder
22 Award; and

23 WHEREAS, Hard work, dedication, and a thorough knowledge of
24 the insurance industry led to Mr. Berger's election as president of

1 the Independent Insurance Agents of Houston in 2000 and his
2 subsequent election as president of the Independent Insurance
3 Agents of Texas in 2003; and

4 WHEREAS, A devoted husband and father, Mr. Berger has
5 successfully balanced the demands of family and work, enjoying the
6 love and support of his wife, Beth, and his sons, Travis and
7 Patrick; active with the Williams Syndrome Foundation, he is an
8 inspiration to his family, friends, and colleagues, and it is a
9 pleasure to honor him at this time; now, therefore, be it
