- 1 WHEREAS, Any effort to improve the economic situation in the 2 State of Texas is of utmost importance at the present time, and the 3 tourist industry is a growth industry in which Texas has a natural
- competitive advantage over other regions; and 4

- 5 WHEREAS, The TravelTex programs for economic development 6 through tourism have had a high degree of success in job creation and socioeconomic improvement in the state; and 7
- WHEREAS, The current system of Texas Travel Trails does not 8 address the needs of the area in what is now Texas House of 9 Representatives District 80; and 10
- WHEREAS, A study and application for a "Conquistador Travel 11 12 Trail" in what is now the Middle Rio Grande Development Council 13 (MRGDC) Region 24 was submitted by the City of Eagle Pass in 1972 but was never formally approved; and
- WHEREAS, The needs identified by and various recommendations 15 included in a South Research Associates study, which was funded by 16 Model Cities and the United States Economic Development Agency, 17 18 were addressed and implemented; among these was the creation of the Room Occupancy Tax entity, which has been collecting taxes since 19 20 then and is still a viable and well-funded agency; and
- 21 WHEREAS, Information in the Texas Historical Commission's 22 Texas Heritage Trails program indicates that House District 80 and counties in the MRGDC area have been assigned to existing Texas 23 24 Travel Trails regions, and the commission is not accepting

- 1 applications for new Texas Travel Trails designations; and
- 2 WHEREAS, This hampers economic development in the area and
- 3 fails to recognize its historical significance; numerous
- 4 historical documents establish that the "El Camino Real Travel
- 5 Trail," which extends from the Rio Grande crossings at Paso de
- 6 Francia and Pacuache in Maverick County to the Missions Trail in
- 7 Bexar County and continues to the segment now known as the
- 8 Independence Trail and Louisiana, had the most influential impact
- 9 on the exploration, development, and settlement of the south
- 10 central and southeastern United States; and
- 11 WHEREAS, House of Representatives District 80 and the
- 12 counties encompassed by the Middle Rio Grande Development Council
- 13 can benefit greatly from the highly successful TravelTex programs
- 14 and the marketing tools and resources available under the
- 15 sponsorship of the Texas Department of Transportation and the
- 16 Governor's Office, Economic Development and Tourism; now,
- 17 therefore, be it
- RESOLVED, That the House of Representatives of the 78th Texas
- 19 Legislature, 4th Called Session, designate the route delineated in
- 20 the attached map as "El Camino Real Travel Trail" for House District
- 21 80 and the counties of the Middle Rio Grande Development Council.
