- 9 she has managed the spending analysis section in the office of the
- 10 comptroller of public accounts and served as a special assistant to
- 11 the director of the Texas Legislative Council; and
- 12 WHEREAS, A graduate of Texas A&M University, where she
- 13 received a bachelor's degree in political science, Ms. Beckett went
- on to earn a master of public affairs degree from the Lyndon B.
- 15 Johnson School of Public Affairs at The University of Texas at

- WHEREAS, After stepping down from her post at ERS, Ms.
- 18 Beckett will be moving to Belgrade, Serbia, where she will join the
- 19 staff of the U.S. Treasury Department and serve as resident budget
- 20 advisor to the Serbian minister of finance and economy; and

- 22 unstintingly of her talents and expertise in behalf of the people of
- 23 Texas, and her unwavering commitment to this state and its citizens
