

(1) On page 1, line 14, strike "After" and substitute "Not later than".

(2) On page 4, line 12, between the second comma and "or", insert "an original equipment manufacturer's remanufactured engine,"

(3) On page 9, line 3, strike "10,000 pounds or more" and substitute "greater than 8,500 pounds".

(4) On page 9, line 11, strike "___ [72]" and substitute "87.5 [72]".

(5) On page 9, line 21, strike "11.5" and substitute "9.5".

(6) On page 10, strike line 3 and substitute the following:
that:

(A) was engaged in research related to air quality on January 1, 2003;

(B) is directed by persons residing in the Houston-Galveston-Brazoria and Dallas-Fort Worth nonattainment areas; and

(C) is based in Houston; and

(7) Insert the following appropriately numbered sections and renumber subsequent sections accordingly:

SECTION __. Subchapter H, Chapter 2155, Government Code, is amended by adding Section 2155.451 to read as follows:

Sec. 2155.451. VENDORS THAT MEET OR EXCEED AIR QUALITY STANDARDS. (a) This section applies only to a contract to be performed, wholly or partly, in an affected county, as that term is defined by Section 386.001, Health and Safety Code.

(b) The commission and state agencies procuring goods or services may:

(1) give preference to goods or services of a vendor that demonstrates that the vendor meets or exceeds any state or federal environmental standards, including voluntary standards, relating to air quality; or

(2) require that a vendor demonstrate that the vendor meets or exceeds any state or federal environmental standards, including voluntary standards, relating to air quality.

SECTION __. Subchapter Z, Chapter 271, Local Government Code, is amended by adding Section 271.907 to read as follows:

Sec. 271.907. VENDORS THAT MEET OR EXCEED AIR QUALITY STANDARDS. (a) In this section, "governmental agency" has the meaning assigned by Section 271.003.

(b) This section applies only to a contract to be performed, wholly or partly, in an affected county, as that term is defined by Section 386.001, Health and Safety Code.

(c) A governmental agency procuring goods or services may:

(1) give preference to goods or services of a vendor that demonstrates that the vendor meets or exceeds any state or federal environmental standards, including voluntary standards, relating to air quality; or

(2) require that a vendor demonstrate that the vendor meets or exceeds any state or federal environmental standards, including voluntary standards, relating to air quality.

(8) Add the following appropriately numbered section and renumber subsequent sections accordingly:

SECTION __. Section 386.101(6), Health and Safety Code, is amended to read as follows:

(6) "On-road diesel" means an on-road diesel-powered motor vehicle that has a gross vehicle weight rating of greater than 8,500 [10,000] pounds [or more].
