## **DIGEST AND PURPOSE**

Currently, no municipal development district (MDD) exists near Cedar Creek Lake in Henderson County. H.B. 2533 creates an MDD near Cedar Creek Lake in Henderson County. The Lake View Management and Development District would have powers granted to MDDs, including the authority to impose taxes, issue bonds, and the power of eminent domain.
