BACKGROUND AND PURPOSE

Current Texas law makes marriage license applications open to public inspection, including such personal information as an applicant's name, social security number, and address. The availability of information related to applicants' social security numbers put applicants at risk for certain crimes, such as identity theft. The purpose of Senate Bill 174 is to make information related to an applicant's social security number confidential and prohibit the county clerk from disclosing such information, and to require the county clerk to redact such information from an application upon receiving a request to make information in a marriage license application available under Chapter 552, Government Code.
