BACKGROUND AND PURPOSE

Currently, provisions in the Government Code relating to construction manager-at-risk and construction manager-agency are not parallel to provisions in the Education Code. The purposes of Senate Bill 1331 are to align the Education Code and Government Code provisions, to add language to the Government Code which authorizes the Texas Building and Procurement Commission to use a construction manageragent method for a project, and to modify the Education Code and Government Code sections relating to the selection of a construction manager-at-risk.
