S.B. 1885 By: Janek County Affairs Committee Report (Unamended)

DIGEST AND PURPOSE

Municipal management districts are political subdivisions of Texas and have only the powers and authority provided by the statute by which the district was created. S.B. 1885 provides for the creation of the Sienna Plantation Management District and provides for the district's authority to impose assessments, taxes, and fees, and issue bonds.

RULEMAKING AUTHORITY

It is the committee's opinion that this bill does not expressly grant any additional rulemaking authority to a state officer, department, agency, or institution.

SECTION 32. EFFECTIVE DATE. This Act takes effect immediately if it receives a vote of two-thirds of all members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2003.
