**DIGEST AND PURPOSE**

Currently, certain counties do not have a regional water authority. C.S.S.B. 1902 creates the Rio Grande Regional Water Authority as a conservation and reclamation district within Cameron, Hidalgo, Starr, Willacy, Webb, and Zapata counties.

**RULEMAKING AUTHORITY**

This bill does not expressly grant any additional rulemaking authority to a state officer, institution, or agency.
