## A BILL TO BE ENTITLED

- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. HEALTH AND HUMAN SERVICES COMMISSION: MEDICAID
- 6 ACUTE CARE COSTS. (a) Out of the Economic Stabilization Fund 0599,
- 7 the amount of \$460,300,000 is appropriated to the Health and Human
- 8 Services Commission for use during the remainder of the state
- 9 fiscal year ending August 31, 2003, for the purpose of providing
- 10 services under the state Medicaid acute care program.
- 11 (b) The money described by Subsection (a) of this section
- 12 may be expended only for the purpose described by Subsection (a) of
- 13 this section and only if:
- 14 (1) Medicaid expenditures exceed otherwise available
- 15 revenue because of changes in caseloads or costs or because of a
- 16 lower federal match rate; and
- 17 (2) the Health and Human Services Commission has used
- 18 all revenue available and appropriated to the Medicaid program,
- 19 including but not limited to premium credits and vendor drug
- 20 rebates.
- 21 SECTION 2. DEPARTMENT OF HEALTH: TEXAS HEALTH STEPS/MEDICAL
- 22 TRANSPORTATION. Out of the Economic Stabilization Fund 0599, the
- amount of \$6,900,000 is appropriated to the Department of Health
- 24 for use during the remainder of the state fiscal year ending August

- 1 31, 2003, for the purpose of the Medicaid programs operated by the
- 2 Department of Health, including Texas Health Steps and the Medical
- 3 Transportation Program.
- 4 SECTION 3. HEALTH AND HUMAN SERVICES COMMISSION: CHILDREN'S
- 5 HEALTH INSURANCE PROGRAM. Out of the Economic Stabilization Fund
- 6 0599, the amount of \$26,400,000 is appropriated to the Health and
- 7 Human Services Commission for use during the remainder of the state
- 8 fiscal year ending August 31, 2003, for the purpose of providing
- 9 services under the Children's Health Insurance Program.
- 10 SECTION 4. DEPARTMENT OF HUMAN SERVICES: TEXAS INTEGRATED
- 11 ELIGIBILITY REDESIGN SYSTEM. Out of general revenue dedicated

- 13 345, the amount of \$26,400,000 is appropriated to the Department of

- 17 SECTION 5. TEXAS EDUCATION AGENCY: TECHNOLOGY ALLOTMENT.
- 18 (a) Contingent on legislation being enacted by the 78th
- 19 Legislature, Regular Session, 2003, that becomes law and that
- 20 authorizes the use of money in the Telecommunications
- 21 Infrastructure Fund to fund the per student technology allotment
- during the state fiscal year ending August 31, 2003, the amount of
- 23 \$116,000,000 is appropriated to the Texas Education Agency out of
- 24 general revenue dedicated account number 345, Telecommunications
- 25 Infrastructure Fund No. 345, for use during the state fiscal year
- 26 ending August 31, 2003, for the purpose of funding the existing \$30
- 27 per student technology allotment.

(b) In the event legislation described by Subsection (a) of this section does not become law, the amount of \$116,000,000 is appropriated to the Texas Education Agency out of State Textbook Fund 0003 for use during the state fiscal year ending August 31, 2003, for the purpose of funding the existing \$30 per student technology allotment.

OFFICE OF THE GOVERNOR: TEXAS ENTERPRISE FUND. SECTION 6. Contingent on legislation being enacted by the 78th Legislature, Regular Session, 2003, that becomes law and that creates a Texas Enterprise Fund that among other things may be used by the governor for purposes related to economic development, the amount of \$295,000,000 is appropriated out of the Economic Stabilization Fund 0599, with the amounts transferred to the Texas Enterprise Fund, for use by the office of the governor during the two-year period beginning on the date that the legislation creating the Texas Enterprise Fund takes effect for the purposes specified in the legislation creating the Texas Enterprise Fund.
