## A BILL TO BE ENTITLED

AN ACT

2	relating to establishing a permanent fund for certain veterans'
3	care purposes.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter G, Chapter 403, Government Code, is
6	amended by adding Section 403.108 to read as follows:
7	Sec. 403.108. PERMANENT FUND FOR VETERANS' CARE. (a) The
8	permanent fund for veterans' care is a special fund in the state
9	treasury outside the general revenue fund. The fund is composed of:
10	(1) money transferred to the fund at the direction of
11	the legislature;
12	(2) gifts and grants contributed to the fund; and
13	(3) the available earnings of the fund determined in
14	accordance with Section 403.1068.
15	(b) Except as provided by Subsections (c) and (e), money in
16	the fund may not be appropriated for any purpose.
17	(c) The available earnings of the fund may be appropriated
18	<u>to:</u>
19	(1) the Veterans' Land Board for programs relating to
20	veterans' homes under Chapter 164, Natural Resources Code;
21	(2) the Texas Veterans Commission:
22	(A) to make grants to counties for the purpose of
23	purchasing burial grounds for veterans under Section 713.029,
24	Health and Safety Code; and

- 1 (B) if the commission is authorized to do so
- 2 under other law, to design, build, and operate a system of state
- 3 veterans' cemeteries; and
- 4 (3) the Texas Veterans Commission to improve or
- 5 enhance veterans' health care and to make grants to local
- 6 communities to address veterans' health care needs.
- 7 (d) The Texas Veterans Commission may adopt rules governing
- 8 the award of grants by the commission under this section.
- 9 (e) The comptroller may solicit and accept gifts and grants
- 10 to the fund. A gift or grant to the fund may be appropriated in the
- 11 same manner as the available earnings of the fund, subject to any
- 12 limitation or requirement placed on the gift or grant by the donor
- 13 or granting entity.
- 14 (f) Sections 403.095 and 404.071 do not apply to the fund.
- SECTION 2. Section 403.1068(a), Government Code, is amended
- 16 to read as follows:
- 17 (a) This section applies only to management of the permanent
- 18 funds established under Sections 403.105, 403.1055, 403.106,
- 19 403.1065, [and] 403.1066, and 403.108.
- 20 SECTION 3. On the effective date of this Act, the
- 21 comptroller shall transfer \$150 million from the general revenue
- 22 fund to the permanent fund for veterans' care established by
- 23 Section 403.108, Government Code, as added by this Act.
- SECTION 4. This Act takes effect September 1, 2003.
